On 12/14/13, this Investigator received a request from Arapahoe County Sheriff's Office (ACSO) Sgt. ROB HOFFMAN to assist with student interviews at Powell Middle School. During that time, this Investigator interviewed:



advised she is a senior at Arapahoe High School and was in the library at the time of the incident. **Finite** provided a written statement, in which she advised the following, that:

"I was sitting in the library at one of the front tables. We heard two loud noises. I thought it was a loud noise from someone dropping a book or slamming a door. A few seconds later, Karl walked in and yelled, 'Where the fuck is Murphy.' Karl was dressed up in a disguise that looked like Robin Hood. He shot the gun a few times. It was like a big gun that is used for hunting. I ran and hid behind a book shelf that was close by. My friend and I were behind the book shelf with one other male student. We heard him coming closer. He shot again and I saw the bullet shell fall on the ground next to me. We crawled further away from the end of the book shelf and I saw an open back door. I think that it was the one that Mr. Murphy ran out of and my friend and I ran out into the east parking lot. Mr. Murphy was standing at the end of one of the back rows of cars and waived us down and told us to keep running towards the Burger King off Dry Creek and University. A Special Service teacher was standing at one of the street corners and took us to Burger King, where I called my mom from and was picked up around 1:00. I had a class with Karl sophomore year, English 10, he was a very smart kid but was also very outspoken and verbally aggressive. In class one day, I remember him making a comment about Hitler and shooting guns. I was taken aback by the comment and remembered thinking that if there was one kid to do a shooting in the school, it's him."





On 12/14/13, this Investigator was requested to respond to Powell Middle School to assist with conducting interviews of witness students related to this case. This Investigator responded to Powell Middle School with Arapahoe County Sheriff's Office (ACSO) Investigator TIM ROTTER. This Investigator and Investigator ROTTER were set up in a classroom adjacent to counseling sessions. The Crisis Counselors at the school were advised to direct any witnesses who had not been interviewed and witnesses who had additional information to provide to this Investigator and Investigator ROTTER.

The hallway was extremely smoky to my left and saw the silhouette of a person walking towards me but could not make out what he looked like. I turned right and sprinted out of the doors by forum in the science wing. followed close behind me as we ran all the way down to the exit by the tennis courts. I ran into Franklin Street and jumped, screamed, waived my arms at the first car I saw driving by. The male driver stopped his truck and rolled down the window, so I said, "There is a shooter in my school, can we get in your car?" Then he let me, and another boy, into his truck and drove us to Southglenn Mall, where he let us use his phone to call our parents. All of our parents picked us up from the Best Buy

He heard the shooter come into the library.

He had already put his head and upper body under the desk.

He heard one more shot which he thought went into the ceiling of the library and he heard the shooter yell, "Where is MURPHY" twice.

He saw what he thought was stucco falling.

During that time, it sounded like the shooter was reloading the weapon.

The shooter passed by him into the library.

He then heard two more shots in the library.

That's all he remembers until the police arrived and escorted him out of the library.

He does remember smelling gasoline but he does not remember any flames.

He also remembers smelling smoke but not sure if it was gunpowder smoke or fire smoke.

He did not see the shooter because he had his head underneath the desk at the time.

He doesn't know what happened to Mr. MURPHY.

l obtained **second**'s personal information and his mother's information. I gave him my card and asked him to call me if he remembered any more details.

I was then asked to interview another student identified as:



said that:

He was pretty sure that the shooter is a student he knows as KARL, although he was in class at the time of the shooting.

The reason he believes it is KARL is because KARL has been disruptive this week in class.

KARL was kicked out of Spanish class on Wednesday for acting out.

The teacher who had KARL removed from class is Mr. LOMBARDI.

He thinks he heard KARL talking about getting a gun about two months ago.

He thought KARL was suspended as he didn't see him on Friday but did see him on lunch Thursday but didn't talk to him.

I obtained personal information and his mother's information. I gave him my card and asked him to call if he remembered any additional information.

As there were no more students to interview at the church, I was detailed back to the Command Post on University Boulevard. Once there, I was detailed to bring one of the school maintenance workers, identified as:

VIDRIO, FABIAN DOB:

to ACSO Headquarters for an interview. Investigator RICK SHEETS was detailed to bring two other individuals to Headquarters for interviews also.

Upon arrival at Headquarters, I put FABIAN in Interview Room 3407 and conducted an interview about his part in the situation at Arapahoe High School. FABIAN advised the following:

He had been in the cafeteria finishing up cleaning up after lunch which ended about 1225 hours.

He was walking to his office behind the boiler room and he saw a young man jogging across the baseball field with what appeared to be a shotgun.

He looked at the person and the person looked at him but didn't slow down.

The young man was too far away to recognize him.

He is familiar with shotguns and knew from the size and shape that it was a shotgun.

He immediately radioed into Security about someone running into the school with a weapon.

He yelled for them to lockdown the school.

The young man went into the doors on the north side of the building by the gymnasium/library.

Those doors are supposed to be locked but students are always blocking them open.

The students block the doors so they don't have to walk around to the front of the school.

He heard gunshots when the young man went in the doors.

As soon as heard the shots, he called 911.

He went to his truck and was going to go across the street for safety purposes.

As he was getting in his truck, TRACY MURPHY ran out and jumped in his truck.

He took TRACY across the street to the shopping center on University, directly east of the high school.

TRACY told him that the person had taken a shot at him.

TRACY also said the person that shot at him was KARL PIERSON.

He also said that KARL was angry because he had "demoted him."

That concluded the interview. On the way back to FABIAN's vehicle in the parking lot of the shopping center on South University, he advised that:

While standing across the street watching everything happen, he had been contacted by the news and had given them an interview.

He had taken a call from his boss and his boss is upset that he had said anything to the news.

He had no idea what happened to TRACY.

I returned FABIAN to his vehicle and went back to the Command Post area. At that point, I was contacted by Sgt. CHRISTOPHER CAMPBELL and directed to go to the school and meet up with Sgt. HOFFMAN and Lt. HEATON for further assignment.

Once at the school, I met with Sgt. HOFFMAN and Lt. HEATON and was advised to standby for additional tasks. Later, myself and Investigator TIM ROTTER were detailed with Criminalist ANDREA STEPHEN to walk the scene before any evidence collection occurred. We were in the cafeteria at the time. We left the cafeteria through the northwest doors into the hallway to the library. The hallway appeared normal and there was no sign of any issues until we came to the end of the hall just past the library entrance. In the intersecting hallway there was a bench against the wall across from the entrance to the school. There was a large amount of blood and debris scattered around the bench. I could see where shotgun pellets had struck the brick behind the bench about head level and left an indentation in the brick. I saw two spent shotgun rounds in that area.

We then entered the library which smelled heavily of gasoline. Just past the front desk and offices, I could see where a fire had begun and had gone up the wall. Someone had put out the fire with water from flower vases. There was one Mountain Dew bottle lying near the burned area. I then walked by the bookcases on the northeast wall of the library. The bookcases are about 4.5' tall. The body of the shooter was located between the last bookcase and the second to the last bookcase.

Earlier I had seen a DMV photograph of KARL PIERSON, the suspected shooter. The body appeared to be that of KARL PIERSON. The body had severe deformation of the head due to a shotgun blast which appeared to enter from below the jaw. There were two Mountain Dew bottles lying by the body that had been made into Molotov cocktails. There were two bandoliers on the body containing numerous shotgun rounds. There was a sheathed machete attached to the waist. The shotgun used had been made safe and was lying at the end of the bookcase.

After completing the viewing of the library, we returned to the cafeteria and helped with task assignments for the next day. Investigator ROTTER and I were dismissed at approximately 2330 hours.





The interview with DARRELL was conducted by Investigator McKENZIE and this Investigator in Interview Room 3406. Although the interview was recorded using the Arapahoe County Investigations interview system, the microphone in room 3406 was not working properly and the audio is very faint in the recording. ACSO Investigator Tim EVANS downloaded and booked the recording from the interview room into the ACSO evidence section even though the audio could not be heard. Investigator McKENZIE had his digital recording device, which recording was later downloaded onto a CD and booked into the ACSO evidence section by Investigator EVANS. Information in the interview has been paraphrased as follows:

DARRELL stated the following:

On 12/13/13 at about 1220 hours, he was having lunch and he heard some Spanish and he (DARRELL) thinks it was FABIAN, later identified as:

Last spring and this semester, KARL had erratic behavior.

Last spring, KARL had a run-in with a Math Teacher where KARL was quoting JULIUS CAESAR, a Shakespeare Play about the Ides of March, and a conspiracy that people are out to get him.

This started when KARL would be blowing up at his classmates, stating that they were all fucking morons and stupid idiots and stuff like that.

The incoherent rambling started when KARL was talking to another Assistant Principal.

DARRELL doesn't know the identity of the victim at this time and if there is a relationship between CLAIRE and KARL.

DARRELL recognized her as a student but not a name.

He just got her out.

He could see a pulse in her neck and that she was seizing.

DARRELL never saw KARL and didn't go past the north hall and the library is north of that.

About two to three weeks ago, Campus Security saw KARL looking at a weapons site on his (KARL's) computer which, besides the volatile outbreaks, is another reason that Security was aware of KARL and keeping an eye out.

KARL was just one of those kids that you kind of get a feeling.


On 12/13/13 about 1215 or 1220 hours, it was his lunch time which varies from day to day but on 12/13/13 he had the late lunch.

ROD got to the end of the trophy hallway with Deputy ENGLERT.

There was a backpack there.

CLAIRE's head was facing west or northwest.

He had heard different things on the radio that KARL was in the library or dead or shot; a lot of stuff on the radio but he didn't get any more than that.

DARRELL had information that the shooter was KARL PIERSON.

KARL does have a reputation about being troubled and Security was definitely aware of him.

ROD had seen KARL around and been aware of him because he heard KARL gets pretty mad about things and there were people concerned about KARL.

ROD wasn't aware of anything that KARL had advertently done other than he would get upset and be irrational at times or angry.

After rescue left, ROD stayed at the Study Center.

ROD is aware that there was some kid that had an issue with TRACY MURPHY but he wasn't sure if that was KARL.

ROD doesn't know any friends of KARL.

Every time ROD saw KARL, KARL was alone.

ROD indicated that there is an entrance by the library called The Forum which is kind of the tiered classroom area that joins the library.

Once the kids are in for the morning, that door is locked, but if a "kid" knocks, other kids will open the door for them.







I assisted with the execution of the search warrant after the residence had been cleared for officer safety. In the attached garage there was a large green plastic trash bin with a closed lid. On top of the lid I located a strip of white fabric and a white t-shirt. The strip appeared to be from the white t-shirt. I also located a red gas can containing an unknown liquid on the floor of the garage. This gas can was next to the northeast wall of the garage.

All items were collected and later submitted into ACSO Evidence.

I also located an "Acceptance of Referral/Recommendation for Service" Form dated 9/9/13 for KARL PIERSON on the dresser in the master bedroom. This stated that is was for an assessment completed on 9/9/13 and appeared to be signed by KARL and MORGAN CAMPAS, LCSW. On 121413, 1230 I was directed by Lt. KEVIN HEATON to attempt to contact the Littleton Public School District attorney, DARRELL FARRINGTON, who was reported to be in possession of KARL PIERSON's Littleton High School records. Initially, the records were believed to be kept at the high school administration area but that they had been turned over to FARRINGTON. Mr. FARRINGTON was present the previous day when a court order was served to obtain the records that the school possessed.

At 1248, I phoned FARRINGTON at **Exercised** and I spoke with an administrative assistant who advised that Mr. FARRINGTON was away from the office and unreachable by phone. I explained who I was and that it was important to contact FARRINGTON reference obtaining documents that he had, that were listed in a served court order. I received Mr. FARRINGTON's cellular phone number and I was told that it was the best way to contact him. I tried the cellular number, **Exercised** and I reached the same administrative assistant, as the cellular phone was transferring all calls to the office number. I explained the urgency of my request to the administrative assistant and asked that she contact Mr. FARRINGTON and have him call me.

At 1302 I received a phone call from Mr. FARRINGTON who denied that he had any files or documents involving KARL PIERSON. Mr. FARRINGTON then asked what documentation that I was trying to obtain and I explained that I was told that all the files in question were reportedly turned over to Mr. FARRINGTON by school administration officials prior to the service of the court order. I explained that the documents were important in the furtherance of our investigation and that his unwillingness to cooperate constituted a potential obstruction of our criminal investigation. Mr. FARRINGTON again stated that he didn't have any files or documents and didn't like the insinuation that he was being uncooperative. Mr. FARRINGTON advised that he would look into the situation and call me back.

At approx. 1310 I was confirming information with Lt. HEATON who further advised that apparently a file previously thought to be elsewhere, was located in the Assistant Principal, DARRELL MEREDITH's school office. I spoke with the Director of Secondary Education, Littleton Public Schools, CLAY ABLA, who was on the phone with Mr. FARRINGTON. Mr. ABLA said that there was confusion as to which DARRELL had the documents and that a file was actually in MEREDITH's possession. Mrs. CASARA was in the process of making a copy of the records that were located in AP MEREDITH's office when I asked where the documentation concerning a threat assessment done on KARL PIERSON on 090913 was located. Previously, it was believed that the school administrative staff had filed the threat assessment with the file that was located in MEREDITH's office but the paperwork wasn't there. Both CASARA and LINDSTONE were unsure of the location of the threat assessment paperwork and I asked if I could speak with Littleton Public Schools, Chief Information Officer, Dr. DAN MAAS to clarify who had what paperwork and where it could be located. Dr. MAAS assured me that an audit had been conducted and that all the available paperwork was being turned over to ACSO. I explained that the file from Mr. MEREDITH's office seemed incomplete and that the threat assessment was unaccounted for.

I then spoke with Littleton Public Schools Director of Security and Emergency Preparedness, GUY GRACE, in a different part of the building and he advised that he had seen the threat assessment and that it should be part of the file that was recovered from MEREDITH's office. Investigator GWALTNEY then called me and advised that she had just been given the threat assessment documents by Dr. MAAS who stated that he obtained it from Mr. FARRINGTON who was somewhere in the building, in a meeting.

I reviewed the threat assessment and it appeared incomplete, there was no documentation reference a scheduled follow-up conference on the threat assessment that was to have occurred on 092613. Dr. MAAS advised that he interrupted Mr. FARRINGTON's meeting to inquire about the missing documentation and Mr. FARRINGTON turned over only the threat assessment documents that he had turned over to Investigator GWALTNEY. Investigator Gwaltney took custody of the copy of the file from MEREDITH's office as well as the documents related to the threat assessment and she continued with the file and documents retrieval from Mrs. CASARA. I then returned to Arapahoe High School where I briefed Lt. HEATON on the documents that were located, where they were located and from whom they were received.





On 12/13/13 at 1237 hours, I received a message from Bomb Squad Commander, Sgt Rich Anselmi, for all Bomb Squad members to respond to Arapahoe High School, 2201 E Dry Creek Rd, on report of an Active Shooter.

I arrived on scene at approximately 1320 hours and met with Sgt Anselmi at the command post across the street from the high school at Chase Bank. The initial information coming in was that a subject entered the school, shot multiple students with a shotgun, and went to the library where he killed himself. Sgt Anselmi advised that he wanted me to recruit another bomb technician to check cars for any possible IEDs on the northeast corner of the school and clear an evacuation route for students to evacuate to the running track. I found that bomb technician Joel White from Douglas County Sheriff's Office (DCSO) was on scene so I brought him with me and started clearing cars starting from the north cafeteria entrance/exit and working to the east. We were eventually joined by fellow bomb technicians, Jae Gates (ACSO) and Eric Vetter and Cesar Madrigal (DCSO). Directly east in the parking lot from the main east entrance I located a mid

covered by brown construction paper. In the tote I could see a dark colored toolbox sitting inside. This appeared very suspicious so I made the decision to break the rear window and clear that area of the vehicle. I did not find anything that appeared to be an IED or IED construction materials.

Once the north and east parking lots were cleared, we were asked by Sgt Anselmi to link up with bomb technician, Troy Waller, who had been inside the school, to split up with SWAT search teams and facilitate the evacuation of the remaining students in the building. After entering the school from the north entrance, we divided up with different SWAT teams and starting searching the school for students who were hiding or sheltering in place or for anything suspicious/possible additional IEDs. (Note: prior to entering we had received information advising that the suspected shooter had possibly used Molotov Cocktails to start a small fire in the library. This information was confirmed by Waller who had been inside the library with fellow Bornb Technician Craig Clark.)

While searching with a search team made up of multiple jurisdictions (ACSO, Greenwood Village PD and Englewood PD) we were advised that there were a large number of kids sheltering in room W115. When we located this room, myself and a GVPD officer had to break the locked, metal, double doors. Once we forced the doors open we located several students inside the room. After they were evacuated, we continued searching and located 25-50 students and teachers in the pool area. After ensuring the evacuation route was safe, they were evacuated as well.

During the search operations we went to the library. The library had officers posted inside for crime scene security. I was told that the only backpack searched in the library was that of the deceased shooter. I then decided that in the interest of scene safety, the rest of the backpacks in the library needed to be cut open and searched. Bomb technicians, Waller, Shay, Joakim (DCSO) and myself conducted a thorough search of all the backpacks in the library.

We then conducted 2 more additional room to room searches, one with SWAT and the final one with explosive detection K-9 where all backpacks in every classroom was searched. Once the final search was complete, we were released from the scene.

On 12/17/2013 at approximately 0716 hours, this Investigator interviewed Arapahoe County Sheriff's Office (ACSO) Deputy James Englert in room 3408. The entire interview was recorded. Refer to the DVD for exact details of the interview.

Deputy Englert advised that he has been a Deputy at ACSO for over 14 years and been a School Resource Officer (SRO) at Arapahoe High School (AHS) for over 6 years. Deputy Englert described what he did on a usual day at AHS.

Deputy Englert continued and advised that kids are use to seeing a Deputy at AHS and he really enjoys working with the kids.

Deputy Englert stated that he was working on 12/13/2014 at AHS and arrived at approximately 0720 hours. ACSO Deputy Bratch was at AHS and they went to Starbucks. The two of them walked around the campus and then Deputy Bratch left prior to lunch. Deputy Englert stated the morning was uneventful and nothing sticks out in his mind. Deputy Englert did not see anything suspicious and did not receive any information that something bad was going to happen at AHS. Deputy Englert stated he got his lunch out of his office and went to cafeteria and he walked into staff eating area and Darrell Meredith, maybe Rod Mauler, Steve Sisler, Brian Jesse were sitting there. Deputy Englert said they were joking around and over the radio he heard an excited voice in Spanish. They kept talking and then he heard a voice that yelled, "Lockdown." Deputy Englert learned later that it was security guard Cameron Rust who yelled lockdown. He ran out of the eating area and saw people running and Rebecca was ushering kids into an office. He got on his radio, his ACSO radio and requested help from dispatch for additional officers. Deputy Englert stated that at this time, he still did not know what was going on, but just in case wanted the cavalry.

Deputy Englert continued and stated he somehow got info that he needed to go down the north hallway towards the library. He believes he saw haziness, almost like smoke in the hallway. As he was running down the north hallway, he was being very descriptive on the radio as to what he knew. Deputy Englert stated he pulled out his gun and was running towards the library. Deputy Englert advised that it was very hectic in the school. He stated he was listening for shots. Deputy Englert stated that Rod Mauler was running down the hall with him and Mr. Mauler told him afterwards that he, Mr. Mauler, heard a pop sound and asked Deputy Englert if he heard that. He asked Mr. Mauler to stay with the injured girl and that Mr. Meredith came up the hallway, he also saw another administrator, Kevin Kolosas, go into the library. Deputy Englert stated he saw shotgun shells on the ground.

Deputy Englert continued and advised that he turned around and did not see any other bodies lying on the ground. Deputy Englert stated that he did not know the injured girls name at the time, but later learned her name was Claire.

Deputy Englert continued and said Mr. Mauler to take the girl (Claire) out the south doors, by the study hall. Deputy Englert stated Mr. Mauler and Mr. Meredith carried Claire down the hall. Deputy Bratch and Deputy Mason then showed up, they continued to listen for shots and the fire alarms go off. Deputy Englert heard that the fires were out in the library and he decided he needed to go to the library and they began to approach the library. Deputy Englert remembers stepping into the library and he saw two legs so he began to give commands. The person came to him and he patted him down. Deputy Englert said there is a room in the library and for some reason he knew that people were in the room. The door to the room opened and he saw Carla who works in the library and Kevin Kolosas. Kevin Kolosas said to him, "It's Karl Pierson." Deputy Englert stated he knew Karl Pierson and was able to picture him in his mind. He stated he got on the radio and said it was Karl Pierson and gave a physical description.

Deputy Englert, Deputy Bratch and Deputy Mason began to clear the library and went to the right and they found Karl Pierson lying on the ground. Deputy Englert said he identified Karl Pierson as the person lying on the ground and he appeared dead as he saw no signs of life. Deputy Englert slid the shotgun away from Karl Pierson. Deputy Englert said that he knew that Karl Pierson did not like Tracy Murphy so he got on the radio and asked where Tracy Murphy was and was told Mr. Murphy was o.k. Deputy Englert stated that he smelled gasoline in the library and members of the bomb squad entered the library to search for explosives.

Deputy Englert continued and stated he exited the library and went into the north hallway and went to Karl Pierson's locker. Deputy Englert said he knew Karl Pierson was a smart kid and was concerned Karl Pierson could do a lot of damage if he put his mind to it. Deputy Englert stated he observed a lot of shotgun shells on the ground in the hallway, but doesn't remember seeing any shells in the library. Deputy Englert said he knew that Karl

Pierson had friends, but was unsure if his friends would be involved.

Deputy Englert stated he heard something as he was initially running down the hallway, but cannot say for 100% that it was a shot from a gun. He stated he never heard a steady pattern of gunshots. Deputy Englert was advised who the injured girl was, Claire Davis, but did not know her at the school.

Deputy Englert, when advised by Kevin Kolosas that it was Karl Pierson, was shocked because he knew Karl Pierson. Has never heard anything about Karl Pierson and Claire Davis being friends, boyfriends or anything else like that. Never heard anything that Karl Pierson and Claire Davis even knew each other.

Deputy Englert had some indication that Karl Pierson entered the school through the forum doors, a feeling because he believed that could be a way to enter the school. He cannot say exactly which door Karl Pierson entered. For arguments sake, if Karl Pierson entered the forum doors, those doors should be locked.

Deputy Englert gave a description of how he believed the doors worked.

Deputy Englert said he will usually check doors throughout the school to make sure they are closes and when they are propped open, he will immediately close them.

Deputy Englert stated he knew Karl Pierson, he hung out in the cafeteria a lot. Some of his friends are Karl Pierson would refer to him as Deputy Englert, he would always say hi. Deputy Englert stated that he did a report concerning Karl Pierson. He said back in September, he met with Kevin Kolosas and Mr. Kolosas said he wanted to tell him something, it's not that big of a deal, but just so you know. Deputy Englert advised that Mr. Kolosas told him that Karl Pierson had been kicked off the Speech and Debate team and Karl Pierson was outside and upset and Tracy Murphy may have been standing outside and Karl Pierson yelled something to Mr. Murphy. Deputy Englert said he spoke to Mr. Murphy about Speech and Debate and Mr. Murphy said there was a debate in Denver and Karl Pierson was talking about a penis during his speech and Mr.

Murphy felt that was inappropriate. Mr. Murphy told Deputy Englert that Karl Pierson had said inappropriate things in debates before. 

Ms. Pierson said that Karl mentored a younger student known only to her as **state that** Karl Ms. Pierson also stated that Karl knew Douglas County Sheriff's Office (DCSO) Sheriff Dave Weaver.

Ms. Pierson said that she attended Gustavus Adolphus College in St. Peter, Minnesota and that Karl had attended a speech camp there.

Ms. Pierson stated that in March or April of 2013, Karl was suspended from school for one day for going off on a teacher.

Ms. Pierson continued and advised that on 08/11/2013, Karl totaled his car after he left McDonalds where he worked. Ms. Pierson said Karl was very angry over something that happened at work and totaled his car after running a stop sign and hitting somebody else. Ms. Pierson stated that Karl does have a lap top computer and it may be in his **see a stop**.

Ms. Pierson said that on 09/03/2013, she received a text message from Tracy Murphy asking to meet with her and Karl. Ms. Pierson said that the meeting occurred at the school with her, Karl and Mr. Murphy. Ms. Pierson stated that when Karl went to Nationals for debate, Mr. Murphy never congratulated him. During the meeting, Ms. Pierson advised that Mr. Murphy said that he didn't feel that Karl was living up to the honor code of the National Forensics League. At the meeting, Mr. Murphy told Karl he would not be the debate team captain and Karl was very angry, but kept it together. Karl then began to say he was going to Kill Mr. Murphy when Karl got outside the building. Karl blew up, saying he was going to kill Mr. Murphy. Ms. Pierson said she kept Karl out of school the next three days. Ms. Pierson then had Karl evaluated at Behavioral Health at Quebec and Park Meadows. Ms. Pierson said they evaluated Karl and advised her that he was not a threat to himself or others. Ms. Pierson said that the blow up concerning Mr. Murphy was on Karl's birthday.

Ms. Pierson stated that during the last week of August 201, she got a call from a male who said he received a call from her home phone number. The male told Ms. Pierson that a male called from her home number and said he was going to kill his daughter. Ms. Pierson said that she spoke to Karl about this and Karl said he

was lost his phone and was calling his phone number but misdialed and called a 7th grade girl and he said he was going to kill her. Ms. Pierson said she received a phone call from the School Resource Officer (SRO) of West Middle School advising her that the girl who Karl threatened to kill went to West Middle School.

Ms. Pierson advised that in the middle of September the principal at AHS told her and Karl that Karl couldn't be on the debate team. The principal said that Karl could got to the debate team tournaments and participate, but couldn't go to team activities. Ms. Pierson stated that Karl's grades were going downhill, he was getting D's and F's.

Ms. Pierson said that when Karl was seeing Beth Teeters at AIM, he received a powder to put in his drink that was supposed to calm him.

Ms. Pierson advised that on 12/12/2013, she receive a text message from Karl that said, "JSYK (Just so you know) I'm going to house tonight and giving \$800.00" Ms. Pierson said that the said is a friend of Karl's and Karl was going to give him the money for flying lessons. Ms. Pierson noted that \$800.00 was in fact taken out of his account on 12/12/2013. After she received the text from Karl, she spoke to him and he said that dad got a raise and he didn't need to give the money to

Ms. Pierson stated that she has erased this text message from Karl.

TACIN NOLT.

Ms. Pierson said that on 12/12/2013, Karl told her that he went to the library and she assumes it was the Lone Tree library on Yosemite.

Ms. Pierson said that on Wednesday (12/11/2013) Karl left his Spanish class to use the bathroom and when he returned, he got locked out and was then pounding on the door and wasn't allowed to get back in. Ms. Pierson said that this really made Karl mad. Ms. Pierson stated that the principal sent Karl home from school for this.

KARL was "very communist" citing a comment KARL made in the 10th grade English class about Adolf Hitler; it seemed like KARL had agreed with Hitler's actions that he took.

Although she did not know him well, KARL's friends described him as a sweet, nice kid, but she did not know him that well and never saw that in him.

On 12/13/13, I received a page to respond to the Command Post inside the Chase Bank located at 7490 South University Boulevard reference an active shooter situation at Arapahoe High School located at:

2201 East Dry Creek Road City of Centennial, Arapahoe County, Colorado

I responded to my residence from the Park Meadows Mall and then responded to the Command Post, arriving at an unknown time; likely around 1445 hours. I checked in with ACSO Investigations Sgt. ROB HOFFMAN and he advised me to assist ACSO Investigator JOHN BARTMANN in interviewing:

> MURPHY, TRACY GENE DOB:

Sgt. HOFFMAN told me that TRACY and Investigator BARTMANN were located within Investigator BARTMANN's vehicle a short distance away. I entered the backseat of Investigator BARTMANN's vehicle and sat down and closed the door. The three of us spoke briefly time prior to responding to Headquarters for a formal interview.

Upon arriving at ACSO Headquarters, I escorted TRACY to the third floor Investigations Interview Room area. Prior to the interview, I oriented TRACY to the interview room and the Investigations bullpen as it was obvious TRACY was visibly shaken by the incident at Arapahoe High School.

At approximately 1637 hours, I conducted an interview with TRACY in Investigations Interview Room #3408. Also present for the interview was Investigator BARTMANN who was taking notes. This interview was audio and video recorded and is, in essence, as follows:

I asked TRACY if he would introduce himself for the record and tell me a little bit about his current assignment at Arapahoe High School and his prior experience in education. TRACY told me that:

He is currently the Arapahoe High School Librarian and this is his 8th year as a librarian at Arapahoe High School.

Prior to Arapahoe High School, he spent 4 ½ years as a librarian at Liberty Middle School, beginning this assignment in 2001.

Prior to Liberty Middle School, he worked with Littleton Public Schools as a Technology Integration Specialist.

Prior to that, he worked in Moffat County and spent 7 years as a Social Studies teacher.

Prior to that, he was a substitute teacher for approximately two years.

Most of his education experience is with middle school and high school.

He holds a K-12 endorsement as a librarian.

His current assignment at Arapahoe High School is as the librarian and he works with kids in various capacities.

The library is a kind of a study hall.

In addition to his primary duties as the school librarian, he is also the head coach for the Speech and Debate Team at Arapahoe High School.

This is his third year as the head coach of the Speech and Debate Team.

I asked TRACY about his duties as the head coach of the Speech and Debate Team and he stated that:

He is responsible for recruiting, prepping the kids for events, helping kids take on leadership roles as well as officer positions within the team.

These roles of leadership within the team are never assigned; the kids volunteer for them.

The kids are held responsible if they sign up for events or for the leadership positions.

He is also responsible for making sure the kids practice.

This position as head coach of the Speech and Debate Team is similar to that of any head coach position for any other sport and their duties.

> He is the coach of a successful team and he most recently placed first this past weekend at the Chatfield High School speech and debate tournament.

TRACY then stated that:

PIERSON, KARL HALVERSON DOB:

was the extemporaneous speech team captain.

I asked TRACY how a student would become an officer and he told me that:

Students would have to express interest and complete a short speech detailing their interest and qualifications.

Also considered in the process is their knowledge base, background and National Forensic League points (NFL points are acquired by placing in the speech and debate tournaments).

Some of the positions are restricted to juniors and seniors only.

Officers are expected to attend a meeting every Monday after school in which they discuss the team, the members and the direction of the team.

They are also expected to attend practice with the rest of the team Tuesday, Wednesday and Thursday after school.

These practices are anywhere from 30 minutes to two hours in length.

There are higher expectations for the officers as follows: They must attend most meetings, practice, competitions and there is clearly more commitment involved.

Last spring, he had reservations about KARL being promoted to the extemporaneous captain.

I asked TRACY why he had concerns about this promotion and he told me:

Extemporaneous speaking consists of current topics.

The students are given a topic and are allowed 30 minutes to prep and then they give a seven minute speech which is graded by a panel of judges.

Between KARL's freshman and sophomore year during the summer, he went to a speech and debate camp.

He did this between his sophomore and junior year as well.

Between his junior and senior year, he did not go to the camp.

KARL placed third and qualified for nationals.

The first and second place qualifiers backed out of the national competition so KARL was able to compete at the national tournament.

Several members of the speech and debate community compete in several events and qualify for nationals on other events and only can compete in one; that is why the first and second place competitor backed out.

I asked TRACY to described KARL and the relationship they had together. TRACY described KARL as:

Nerdy, socially inept and "clunky."

He was hoping that KARL, through the participation in the speech and debate, would "grow and develop self-confidence."

He saw things in KARL last year regarding his leadership and felt that he was not suited for the position.

KARL was not running the extemporaneous practice as TRACY would have liked and they discussed it and KARL was argumentative about it.

TRACY described that:

KARL had the feeling that he knew better than him how to run the practices.

KARL displayed poor decision-making at the tournaments.

In the finals the last school year, KARL participated in a competition that he did not see because he was judging another round at the time.

Other teammates from Arapahoe High School watched KARL's competition and they were buzzing about his opening statement but nobody would talk to TRACY about what exactly KARL had said.

TRACY asked KARL what he had said in his introduction; KARL said I'll show you.

KARL positioned himself in the front of the room and said, "I woke up this morning and realized my penis had fallen off."

TRACY told KARL that this was extremely inappropriate because he was supposed to be talking about current events and this had nothing to do with it.

TRACY told KARL, "You crossed the line."

KARL responded by saying, "I just needed to know where the line was."

He then spoke with KARL about the possibility of his statement construed as sexual harassment and that he representing Arapahoe High School and that this was not appropriate.

Only TRACY and KARL were present for this meeting.

KARL acknowledged that he had made a mistake but dismissed the incident as being over.

KARL did not see the pattern in his behavior and the conversations they had in the past.

Near the end of the school year (2012-2013), he had a discussion about the captaincy stating that the captains could lose their position if they didn't follow through as expected.

In April of 2013, KARL qualified to compete in the national tournament.

KARL saw his achievements and his qualification in the tournament as most important rather than being a good teacher and role model for the other teammates.

During the second day of school this year in the library, he was approached by another teacher, JEFF CORSON, who is a Social Studies teacher.

This year, JEFF teaches International Relations class which is an elective that is open to freshmen, sophomores, juniors and seniors.

There is a mix of kids and abilities and understanding of the world in this class.

JEFF came to TRACY after conferring with Social Studies teachers who told him that KARL was on the Speech and Debate Team and that he should talk to TRACY.

JEFF wanted to know how to deal with KARL because he was telling other kids they were stupid.

> JEFF addressed the class about being thoughtful about each other's skill level and he also pulled KARL aside and spoke to him privately.

JEFF asked him, "How do I get through to him?"

TRACY told him, "Good luck" and "he sees things how he sees things."

TRACY was concerned because KARL is associated with the Speech and Debate Team and he is being seen as "a verbal bully."

A few days later at the Back to School Night, the Speech and Debate Team participated in a fundraiser in which they sold bottled water to the parents in attendance.

KARL had signed up to participate in the event but was a no call/no show and TRACY felt this was irresponsible.

When he spoke to KARL about it, KARL stated his phone was not working.

He wasn't pleased with that answer because he is aware that KARL's mother:

PIERSON, BARBARA DOB: unknown

actually has TRACY's phone number.

Shortly after Back to School Night, TRACY held a meeting with the leadership of the Speech and Debate Team.

TRACY was the only coach of the team in attendance.

At this point, he decided that KARL was to be removed as captain of the extemporaneous team.

He sent a text to KARL and to his mom, requesting a meeting with them later in the day.

He received responses back from KARL and BARBARA stating they would come to the meeting.

Later that afternoon, the meeting was held in the Speech and Debate Room C15, where he expressed his concerns about KARL's behavior and advised that he was being removed as the captain of the extemporaneous team.

He advised that KARL was still on the team and wanted him to participate.

KARL was "livid and threatening."

KARL referred to what the Principal would think about removing the only member of the team who qualified for nationals.

KARL couldn't see that his competitive success was outweighed by his behavioral issues and he cited the example of Terrell Owens.

He told KARL that his decision to remove him as captain was not about competitive success.

Upon telling KARL he had been removed as the extemporaneous captain, KARL looked at him and TRACY said that he had "never had a kid look at me with a look of hatred that he did that day. It was haunting."

BARBARA tried to act as peacemaker and asked KARL to apologize to TRACY and shake hands.

KARL picked up his belongings and then offered his left hand to shake and TRACY felt that this was a sign of disrespect.

BARBARA apologized for KARL's behavior and the bad light that was shining upon the Speech and Debate Team.

KARL has a **meeting**, **the second second who was waiting in the library during this** meeting,

BARBARA asked him to let **Example** know that **See** and KARL would be leaving the building and going directly to the car and to have **see** go out to the car.

TRACY agreed and started walking to the library and then realized the building and the library was closed and that would not be in there.

He turned around and backtracked towards C15 and saw and heard KARL yelling at BARBARA in the hallway.

He described KARL as "yelling and animated" but could not tell what he was saying.

I asked TRACY if he could tell who the yelling was directed towards. TRACY stated:

He thought it was directed towards BARBARA and possibly himself (TRACY).

He has never had a bad feeling about a student like this before.

He decided to see if the Principal, NATALIE PRAMENKO, was in her office and she was.

He wanted to advise her on the interaction with KARL and his history.

NATALIE was supportive of his actions that he had taken and he wanted to tell her a C.Y.A. if the parents got upset about what had happened.

The next morning (Wednesday), he decided he was going to follow up reference the incident.

"We live in a post-Columbine world and it sucks."

He first spoke with a co-worker, ASTRID THURNAU.

He told her about the meeting with BARBARA and KARL and that he had a bad gut feeling.

ASTRID told him that he has "got to go with your gut."

TRACY then spoke with BRIAN JESSE, who is the Arapahoe High School Activities Director.

He advised BRIAN about his concerns with KARL and he wanted to get the information out and touch base with KARL.

He was unable to do this because KARL was held out of school on Wednesday, Thursday and Friday by BARBARA.

Wednesday afternoon, the faculty meeting was held in the forum.

Another teacher, MARK LOPTIEN, pulled him aside.

MARK teaches Technology on the east side of the building.

He told TRACY that on Tuesday, he was out in the parking lot on the east side of the building.

He does not know why MARK was outside; possibly going to his car, taking out trash or something like that.

MARK stated that he heard some screaming from the east entrance with they refer to as "the bubble" and it "sounded like an animal."

MARK looked over and saw a male juvenile, a woman and a juvenile, who he later determined to be KARL, **Sector** and BARBARA. He heard KARL state something to the effect of I'm going to kill that MURPHY.

At this point, he decided "I'm going to follow up on this."

TRACY and MARK then spoke with NATALIE.

NATALLE was supposed to attend a district meeting so she referred TRACY to KEVIN KOLASA.

TRACY spoke with KEVIN and he and MARK shared the information about the incident in the east entrance.

TRACY stated that:

KEVIN called BARBARA that night and BARBARA held KARL out of school for the rest of the week.

KEVIN wanted to treat KARL coming back to school as a "reentry meeting" although KARL was never formally suspended for his actions.

This would consist of a meeting with KARL and his parents before he was allowed back to school.

Anyone who works with kids is going to have confrontations with them; you just have to be patient with them.

The high school kids take longer to win back than middle school kids.

I asked TRACY if KARL ever made any direct threats against him via verbal, text, email, etc. and TRACY said:

Not that he was aware of, although he was so concerned about KARL snapping that he spoke to Arapahoe High School Counselor ESTHER SONG.

KEVIN made the administrative decision to remove the captaincy from KARL and that it was TRACY's decision to allow KARL to still participate in speech and debate against the wishes of the administration.

KARL is opened enrolled and he actually lives in Douglas County.

In his conversation with KEVIN, the district would not support removing KARL from Arapahoe High School and sending him back to Douglas County because he is a senior and near the end of his school career.

KEVIN and ESTHER met with KARL and his parents on that following Monday for the reentry meeting.

KEVIN decided a two to three week cooling down period would be appropriate and that KARL would not attend the speech and debate practices or events during that time.

After the reentry meeting, it further confirmed ESTHER's belief that KARL was a narcissist.

The next day (Tuesday), KARL showed up for speech and debate practice although he was told not to be there.

When TRACY realized he had come to the practice, he told KARL he was not supposed to be there.

KARL left and did not make a scene but he could tell that KARL was clearly not happy based upon his body language.

After KARL left practice, he called KEVIN and told him that KARL had attended practice and was told to leave.

KEVIN stated that he was going to follow up with KARL.

The following day, TRACY participated in a professional learning community meeting from 7 to 9 am; this is a teachers-only meeting in which they discuss best practices.

After this meeting, he was walking to the men's room and he crossed paths with KARL.

KARL walked past him and didn't acknowledge him.

TRACY stated:

"It was like I didn't exist."

I asked TRACY if he noticed if KARL had any ear buds, etc. that would prohibit from hearing and say good morning and TRACY said no. TRACY followed up by stating:

He crossed in front of KARL, said hi to him, and KARL did not respond.

**Between 1737 and 1747 hours we took a short break. Between 1747 and 1751 hours, I had a short informal conversation with TRACY and he said the following:

> "Thoughts were going through my mind months ago. I want to see my grandkids and I don't have any yet and uh, just things I wanna do."

"As I told, as I told people, as much as I care what I do, you know if I wanted to give my life or cause someone else to (long pause)."

**The interview resumed at 1751 hours. TRACY stated that:

KEVIN conducted an additional meeting and in attendance were KARL, his mom and dad, TRACY and ASTRID.

TRACY relayed his concerns to KEVIN and ESTHER and he seriously thought about resigning.

He decided to do this because he wanted to take himself out of the school as a target and this would be safer for him and it would protect others KARL might hurt trying to get to him.

I asked TRACY what gave him the feeling of the need to retire. TRACY said:

He couldn't come up with a better solution.

Arapahoe High School is a big building and it's a sieve with lots of open doors.

Even if KARL's open enrollment was removed, he could still come back to the building.

It would not look odd for KARL to be there because lots of former students visit the school.

"My feelings never went away that this kid is trouble and they just, in my mind, kept building."

I asked TRACY what other circumstances that led him to experience this feeling and he said:

He rarely saw KARL after the September meeting.

"It's a big school but you're gonna cross paths with people."

They did cross paths several times but KARL ignored him.

l asked TRACY, prior to KARL's demotion, how was the interaction between him and KARL. TRACY said that:

KARL would have said hi to him in the past.

I asked TRACY if this situation was different than other students that he had to discipline and he said:

"Yes."

"I'm not saying kids don't hold grudges but at the same time, this was different."

"I mean, not all of them are gonna play out like that. There are gonna be some kids that are always gonna, you know, you know how it goes. Hate that teacher. Hate that Librarian just because. That's just; we've all had that experience probably."

Just prior to school on one occasion (unknown exactly when), he spoke with ESTHER who didn't really know him.

ESTHER was in on the reentry meeting.

TRACY was concerned about KARL being a threat.

In the Monday reentry meeting, ESTHER was in attendance in the meeting and was making a threat assessment.

On one occasion, KARL had come into her office wanting to get an I.Q. test and her interaction with KARL solidified her feeling of KARL's narcissism.

I asked TRACY if he had any other incidents with KARL and he said:

He checks kids grades that are involved with the Speech and Debate Program, KARL included.

This semester, he looked at KARL's grades and realized he was ineligible because he was failing two or three classes and had Ds in a couple of others.

He realized that KARL could not have participated in speech and debate even if he had wanted to.

He thought initially that although KARL wasn't participating in the practices and the competitions that he may have wanted to qualify for state without participating in anything else to prove simply that he could.

At the Monday reentry meeting, KARL was given the speech and debate forms and advised of the \$50 membership fee.

KARL never returned any of the forms or the membership fee.

I asked TRACY if it seemed like KARL had abandoned the idea of being on the Speech and Debate Team and he said:

He did not know.

He did not fill the extemporaneous captain position because he worried that KARL would be mean to the successor.

I asked TRACY about KARL's previous semester's grades and he told me that:

KARL had a B average and he was eligible.

KARL appears to have "tanked it" this semester.

I asked TRACY if he knew what had changed for KARL and he told me that:

The change in his status as captain of the extemporaneous team.

On one occasion BARBARA had told him in October of 2012 at parent/teacher conferences that she and KARL's dad divorced and the dad had moved out.

TRACY had a good parent/teacher relationship with BARBARA and she had asked him to keep an eye on KARL.

A broken family is not unusual for students at Arapahoe High School.

I asked TRACY to describe KARL, prior to October 2012 and his talk with mom about the divorce. TRACY said:

KARL felt good being in a leadership position.

He wanted a successful speech and debate year.

This was the main way he interacted with KARL was through speech and debate.

He never really saw KARL in the library this year; possibly one or two times and "some" prior to this year.

He never set up a hostile environment for KARL after his demotion.

TRACY had spoken with DARRELL MEREDITH and had told him that others on sports teams lose their ability to be the captain because of something they did and they don't go off the deep end; it's simply a "blip in life."

He went on to say that the student might be mad later in life with him but that people go on.

"I felt there was more there."

l asked TRACY if there were other meetings with the family or with the administration since the readmission meeting in September and he said:

Not really.

The only interaction he really had was with **setting** who was in the library on most days.

He believed that knew about the problems with KARL and the Speech and Debate Team and he was cordial to

He did not go out of his way to talk to **because he did not want to put** on the spot.

I asked TRACY if he had any idea how was doing knowing about KARL's problems and he said;

was a quiet person and didn't really see any changes in although he wasn't really looking.

l asked TRACY if he retained any emails, texts, voicemails, etc. from KARL and he said that:

He did not know.

His cellular phone was on his desk in the library at Arapahoe High School and I could look at it.

He doesn't believe that he had any contact with them since the morning meeting.

He had a few interesting observations since the morning meeting.

During the meeting, KARL's father said nothing.

KARL's father gave him "weird, bad vibes."

Dad was "driven" and "stern."

Mom, on the other hand, was open and friendly however he saw that she treated KARL like he was a little kid.

TRACY cited the example of the re-entry meeting, and that BARBARA talked to him like he was a six year old, not an 18 year old; (citing the example of) "You have something to tell Mr. MURPHY now."

He and KEVIN thought the way she spoke with KARL was odd.

The reentry meeting was run by KEVIN KOLASA in which he portrayed that the administration wished to remove KARL from the Speech and Debate Team entirely however TRACY wanted to retain him as a member of the team.

ASTRID commented on the apology that KARL gave to TRACY saying the language KARL used didn't come across as heartfelt.

At the end of the reentry meeting, KARL and his father met at the back of the room.

KEVIN, ASTRID, BARBARA and TRACY stayed in the front and BARBARA tried to smooth things over.

KARL left immediately after speaking with his father.

TRACY went on to talk about KARL's grades saying that:

He knew that KARL wanted to get into the military and wanted to attend West Point.

KARL always wore an Air Force sweatshirt.

He remembers thinking that with his grades being as poor as they were that he would not be able to attend West Point.

Investigator BARTMANN asked TRACY if he was aware of any of KARL's extracurricular activities and TRACY said:

He heard that KARL was a Scout, possibly an Eagle Scout.

MARK LOPTEIN is KARL's Physics Teacher and heard KARL screaming in the parking lot after the Tuesday meeting with KARL and his mother.

KARL is failing his Physics class.

He believes that MARK said that distance was an issue but was fairly certain that the individual yelling was KARL.

He is aware that KARL is not involved in any sports.

TRACY stated that:

Another student, **Sector** competed in the extemporaneous speaking competitions.



has a stutter but has done very well.

wanted to quit but TRACY talked him in to staying and as a result, ended up placing fourth at state.

had expressed interest in being extemporaneous captain and stated that he was going to run against KARL but chose not to.

made a statement to TRACY that KARL's mouth finally got him into trouble.

Other speech and debate students had asked TRACY about KARL but stated he couldn't talk about it because of FERPA (Family Educational Rights and Privacy Act).

**At 1823 hours, we took a short break and resumed again at 1839 hours. During the break, I made copies of the Arapahoe High School floor plan and color map of the high school.

In coming back from the break, TRACY stated that there was something else that he wanted to mention.

NATALIE followed up with TRACY after the Wednesday Faculty meeting, reference KARL's outburst after the Tuesday afternoon demotion metting.

He recalls speaking with KEVIN about possible surveillance video, feeling as though the surveillance video should be pulled to give an idea of what had happened.

Two to three days later, he spoke with KEVIN and the surveillance hadn't been pulled and he got the impression that it was not going to be done.

He decided he was going to talk to DARRELL whose main job for Arapahoe High School is maintenance and security for the building.

DARRELL was busy so he talked to DARRELL's secretary, JILL DEBOSE.

JILL stated that she would go ahead and look into it, but it was two weeks after the incident.

JILL reported back to him that she was unable to locate the footage because it had already been written over.

"This was a step that we missed" and "to see where this kid was emotionally."

I then asked TRACY to run us through the events of the day, 12/13/13. He stated:

He arrived at school at about 0648 hours which was approximately three minutes late.

His coworker, KARLA BRACHTENBACH, was already there.

During the day, they were swapping netbooks in the library out for classroom netbooks which were newer.

They were cleaning up the netbooks, getting stickers off, putting barcodes on and sorting out the power cords.

KARLA went to the first lunch period which is approximately 1030 to 1115 hours.

During this time, the library was not really busy.

When KARLA came back from lunch, the library started to get busy.

He was going to eat but decided he couldn't and he needed to stay and monitor the kids.

He was glad that he did because one student tackled another; he intervened and talked to the student.

He told the student that he probably needed to sit out of the library for the rest of the semester which, in essence, would only be one more school day.

He decided that he wanted to talk to Administrator KEVIN SISLER and tell him about the incident.

He walked down to the main office and another teacher was already talking to KEVIN.

TRACY went back to the library and decided to wait on lunch until 5th period.

The bell then rang, passing period was over and he went into the main office to try and meet with KEVIN.

KEVIN was not in his office.

KEVIN's secretary was also not there.

NATALIE's secretary was there and said that KEVIN was eating in the staff lounge.

He left the main office and started walking towards the staff lounge, and STEVE followed him with a sandwich because he had not eaten either.

He located KEVIN and briefed him on the incident in the library and it seemed like KEVIN had already had interaction with the student earlier in the day.

TRACY then went back to the library and KARLA was still working on power cords in the circulation area.

He grabbed the newspaper and then went back into the work area where the tables are, to eat.

At approximately 1220 to 1225 hours, he was sitting at the table reading his paper eating his lunch and he heard two loud bangs.

These two loud bangs were unlike anything that he had ever heard before.

They did not sound like kids who were acting out and filming something for school or something falling over.

KARLA walked out from behind the circulation counter as he was getting up from the table and they were both walking towards the main door to the library; he was a ways behind her at this point.

KARLA got to a wooden dividing area which funnels the students into the library security gate.

KARLA began to peek out through the door and at that point "the doors busted open" and this was very loud.

He then heard a male voice yell, "Where is MURPHY?"

At this point, TRACY said:

"I just knew it was KARL."

"At that point, this guy comes through and all I see was a gun and I turned around and started running as fast as I could, back the way I came, past um, where I was sitting and about that time, a shot fired out; and I'm not lying. I felt something blow past my head right here (pointing over his left shoulder) and I just ducked down. I thought, God, I just gotta get to KAREN. KAREN GERLICH is our um, Instructional Coach. She offices in what's actually considered the Librarian's office but we never used it that way."

"I'm thinking if I just get through there. I don't know where, if he's gonna come around this way or if he's gonna follow me around. If I can just through that door and get out that; there is an exterior exit right outside her door."

"I'm thinking maybe I stand a chance and maybe I can get away and run out past the boiler room, and I come around the boiler room; that's another building out there; and I think I don't know what to do."

From this position, TRACY believes he ran through the grass and into the parking lot on the east side of the school.

"I thought if he comes out, maybe I can stand a chance; that I could play hide and seek between the cars while you guys (police) maybe could get out there."

At this point, TRACY got behind the corner of a big pickup, crouched down and was watching for kids to start coming out.

He saw two girls running out; he can't think of their names but thought to himself that they were not a part of it because "I could see it on 'em."

He waived to them saying "run across the street."

The girls then ran to the sidewalk on University, ran south towards the stoplight towards the crosswalk and he thought to himself "Come on, girls but I guess we're creatures of habit."

He then saw a boy and he knew he wasn't a part of it, either, and he did the same thing and said, "run across the street; go, go."

His next recollection is seeing a pickup and at first, it scared him thinking "God, it's KARL."

He then realized the side of the pickup had an advertisement on it and realized it's FABIAN VIDRIO, the Head Custodian.

FABIAN's pickup was at the east entrance to the parking lot along University.

He waived at FABIAN; FABIAN was on the phone and FABIAN opened the car door.

He believes he told FABIAN, "It's KARL PIERSON. He came in the library trying to shoot me" or something like this.

He got in FABIAN's car and they drove across University and pulled across the street by the condominiums (I know this street to be East Geddes Place).

FABIAN told him that he saw a guy with a gun and that he radioed in to Security then heard two shots and shortly after heard a third.

At this point, he called 911.

FABIAN told him that he thought he was first to call 911 because Dispatch sounded like they were unaware of any incident occurring at Arapahoe High School.

FABIAN and TRACY then stood at that location and "watching all hell break loose."

He looked at people who appeared to be still walking inside of the building because the building had not been secured yet.

He flagged down a fireman and told him he knew what was happening because KARL was coming for him.

The fireman then flagged down a police officer and the police officer told him to go over into the parking lot near the Command Post.

Not too long later, he believes that he connected with Investigator BARTMANN.

TRACY then said:

He feels like he should have resigned so there wouldn't be a target there at the school.

He believed that KARL was either going to hurt him, kill him or hurt somebody trying to kill him.

"I blame myself for this."

At this point, I showed TRACY a map of Arapahoe High School aerial photograph. TRACY drew his exit out of the building and the subsequent location of his path of travel around the boiler room, through the parking lot and eventually to FABIAN's vehicle on the east side parking lot.

I then showed TRACY a map of the Arapahoe High School floor plan. He diagrammed the location of KARL and his mother and himself after the Tuesday afternoon meeting while KARL was in the hallway screaming at BARBARA.

I then showed TRACY a blown up Arapahoe High School floor plan specifically of the library. TRACY diagrammed the location of KARL, KARLA, himself and his movement through the library as he recalled it.

I asked TRACY to sign and date these diagrams and I booked them all into the ACSO Evidence Section.

Investigator BARTMANN presented a black and white photo to TRACY and he immediately identified the male in the photograph to be KARL PIERSON. TRACY signed and dated this photograph and I booked it into the ACSO Evidence Section.

Upon completing the interview, I walked TRACY to the Victim Assistance Family Room that is adjacent to the interview rooms. TRACY's wife and pastor were there waiting for him.

I left the room and returned a short time later. TRACY and his wife had decided not to return home, rather they had made arrangements to stay elsewhere. TRACY stated that they did need personal items from home, and I made arrangements with ACSO Deputy DAVID WILLIAMSON to meet the pastor at TRACY's residence to gather these items. TRACY told me that Deputy WILLIAMSON was welcome to enter his residence due to the presence of the news media.

On 12/18/13 at about 1600 hours, I was asked by Investigator KRISTIN McCAULEY to contact TRACY and ask him for a list of the Speech and Debate Team members and any possible contact information.

At about 1842 hours, I received an email from TRACY with an Excel attachment of 38 students that participate in the speech and debate ranging from freshmen all the way to seniors. I forwarded this to Investigator McCAULEY.

I will submit a copy of the email and the list that I received from TRACY into the ACSO Records Section.

On 12/17/13, Investigator TIM EVANS gave me a working copy of the audio/video interview that I conducted with TRACY on 12/13/13. I viewed the video and took my own notes that I have used to write this progress report.

Agent STEVENS advised me that he was unable to get into the Nexus because it had a swipe password. He has talked to the FBI and they are trying to find a work around so that he can bypass the swipe password. He will contact me when he is able to get into the Nexus.

I asked Agent STEVENS if he could tell me what contact in the phone is listed to the shows up as Mom Home. Agent STEVENS also gave me phone number (the shows) upon my request.

At approximately 0955 hours, I met with Agent NOREJKO who returned the following evidence to me:

One of the USB drives was encrypted and he was able to break the encryption.

The drive contained a 28 page journal.

I obtained a copy of the journal and gave it to Investigator McCauley. This copy of the journal then was placed into evidence.

On 01/22/14, at approximately 1400 hours, I spoke to Agent HILTON and he advised me that his finally report is done and that I can pick it up from him. I responded to RMRCFL and picked up Agent HILTON's report along with 2 DVD's that
