- Last cell phone internet activity by Cruz on February 13:
 - "Exception" by Token
 - Music video and song telling the story of a student named Andy
 - Andy is repeatedly bullied at school by two classmates
 - Andy goes to the school and shoots the two bullies



Statements by the Sneads about Cruz

- JT last saw Cruz the night of 2/13, Cruz went to bed around 8:00 or 8:30.
- Kimberly saw him the night of 2/13, maybe around 10:30. Cruz was going to get a shower. She did not comment on his demeanor.
- Kimberly also saw Cruz the morning of 2/14. Cruz said he was going fishing. She did not comment on his demeanor.
- JT described Cruz as being depressed for months which was largely triggered by his mother's death.
- James suspected Cruz's mother did everything for him since Cruz didn't drive, cook or do laundry.
- Sneads indicated they had no knowledge of Cruz's plans or reason to have any great concern for his welfare.

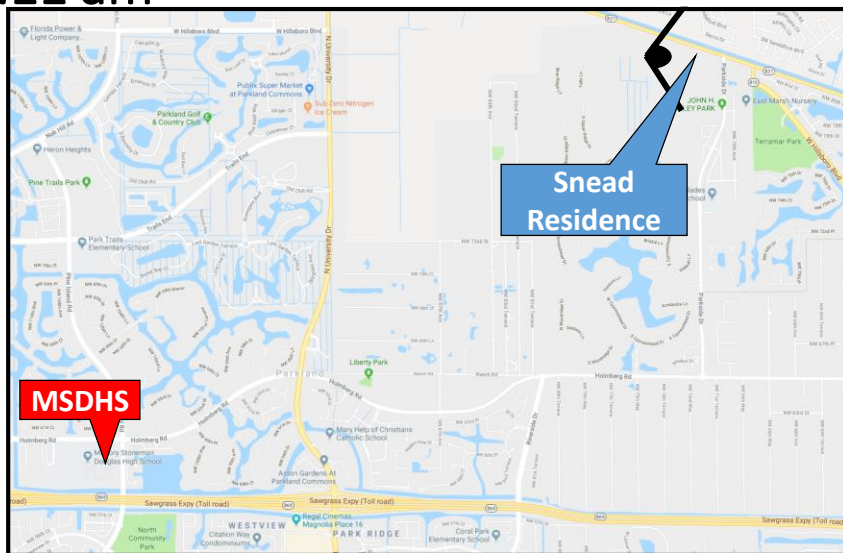

- Cruz attempted a phone call to Jameson "JT" Snead
- Duration: 0 seconds
- Call serviced by a tower immediately west of the Snead residence, 7200 Loxahatchee Rd, Parkland

- Cruz engaged in a text conversation with JT Snead
- Texts were serviced by a tower immediately west of the Snead house
 - Cruz asked if he could let the dogs outside
 - Cruz told JT that his boss called him and he did not have to work that day

9:19:29 am

- Cruz made a 17 second call to the Dollar Tree, 5943 W. Hillsboro Blvd, Parkland
- Call was serviced by a tower immediately west of the Snead house

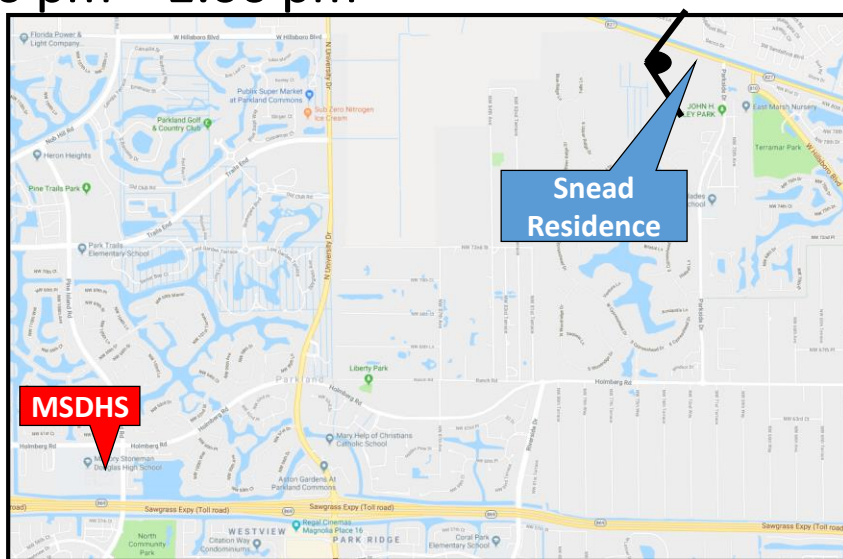


Nikolas Cruz's Activity on February 14, 2018 12:00 pm – 1:00 pm

- Cruz engaged in text conversations with JT Snead and Cruz's ex-girlfriend.
- All cell activity was on a tower immediately west of the Snead house.
 - His ex-girlfriend was saved in Cruz's phone as "Warning Love Of Your Life".
 - Cruz made a single call to her (9 seconds).
 - Cruz and asks JT if some female friends will be coming over later that night.
 - Cruz seems to be in a hurry to find out if they will be coming over because he says that he might go see a movie that night.
 - Cruz attempts to engage his ex-girlfriend in conversation but she tells him to leave her alone.

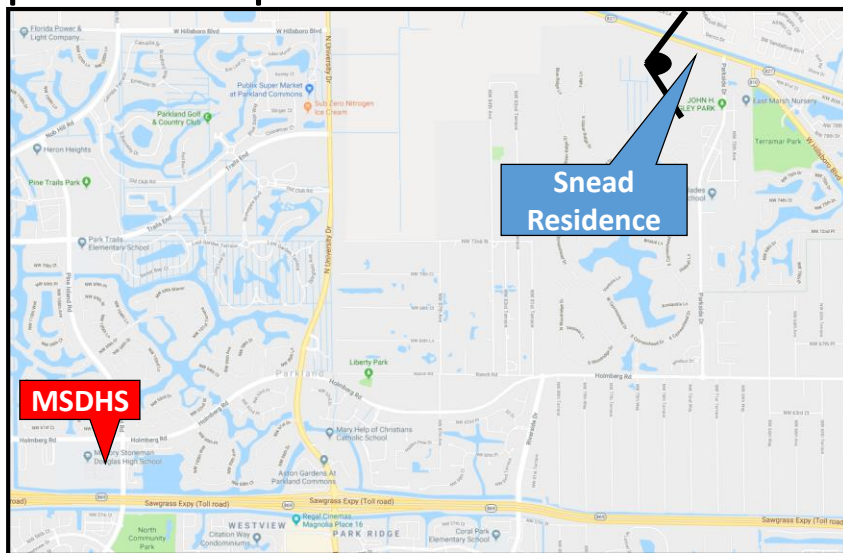


Nikolas Cruz's Activity on February 14, 2018 1:00 pm – 2:00 pm

- Cruz engaged in text conversation with JT and his ex-girlfriend.
- All cell activity was on a tower immediately west of the Snead house.
- Cruz asks JT what time schools ends, which class JT is in and who is JT's teacher.
- Cruz's only texts to his ex-girlfriend were "Hello" and "...it's very important", she did not reply during that hour.

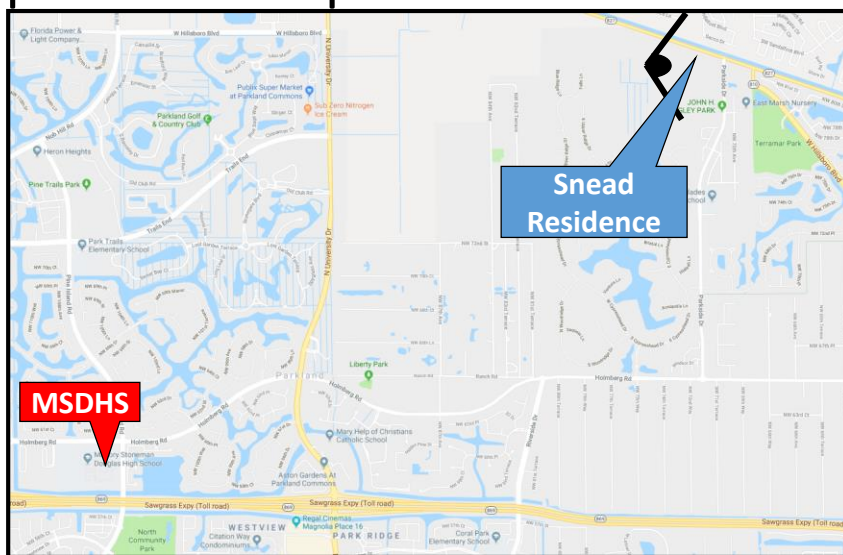


Nikolas Cruz's Activity on February 14, 2018 2:00:00 pm – 2:08:05 pm

- Cruz exchanged six text messages with his ex-girlfriend.
- All cell activity was on a tower immediately west of the Snead residence.
- She chastised Cruz for texting her too much.
- Cruz told her "I love you...You will always know I love you".

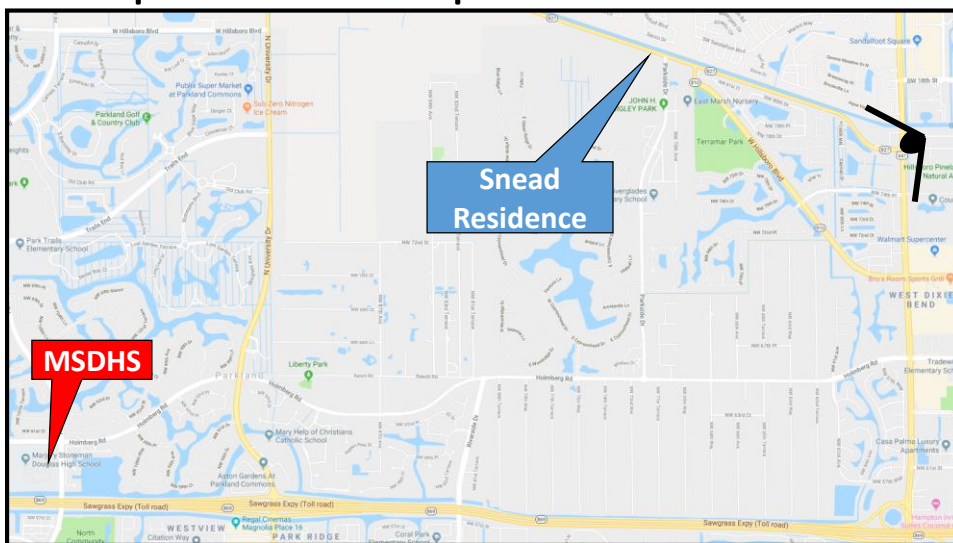


Nikolas Cruz's Activity on February 14, 2018 2:08:44 pm – 2:10:02 pm

- Cruz exchanged 12 text messages with JT and his ex-girlfriend.
- All cell activity was on a tower east of the Snead residence in a path consistent with traveling to MSDHS.
- Cruz tells JT that he has to tell him something important soon.
- Cruz tells his ex-girlfriend "Eat well, sleep well, and behave well my love".
- She asks Cruz "You know I have a boyfriend, right?"
- Cruz responds "Doesn't matter anymore...I love you".

Nikolas Cruz's Activity on February 14, 2018 2:10:09 pm – 2:14:05 pm

- Cruz exchanged 23 text messages with JT and his ex-girlfriend.
- All text messages were on a tower south of the Snead residence and east of MSDHS on a path consistent with his travels.
- Cruz tells JT he's going to a movie which angers JT because he got a girl to agree to come to their house, Cruz responds "too late now".
- Cruz continues to admire his ex-girlfriend saying "Your the love of my life...you're the greatest person I have ever meet".

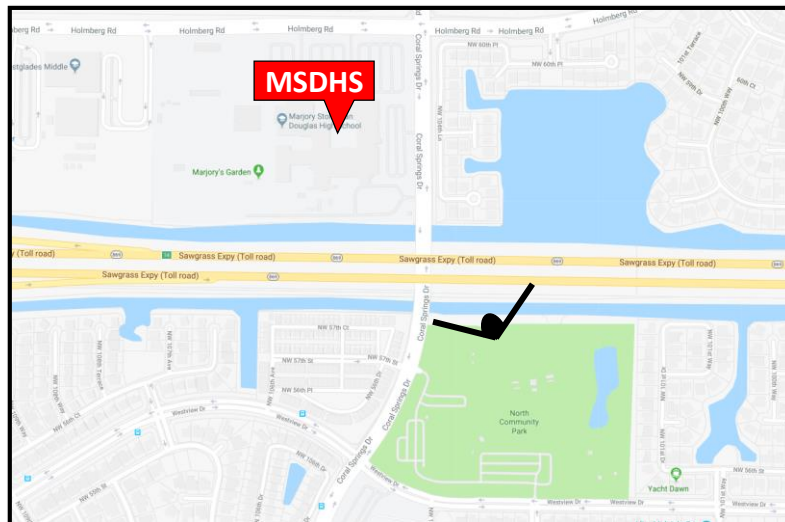
Nikolas Cruz's Activity on February 14, 2018 2:16:54 pm – 3:45:52 pm

- Cruz's phone had 23 text messages and 10 missed calls
- All cell phone activity was on a tower immediately southeast of MSDHS in North Community Park.
- Cruz sent two texts to his ex-girlfriend saying "I love you".
- The last outgoing texts were to JT:
 - 2:18:46: "Yo"
 - 2:18:57: "Tell"
- Uber records show Cruz was dropped off at 2:19pm
- All remaining activity was incoming texts and calls

3:36 – Cruz detained by LE

Nikolas Cruz's Weapons

- One firearm used during the shooting
- One firearm on Cruz during the shooting
- Smith & Wesson, model MP-15
- Semi-automatic
- 5.56 caliber rifle
- Sling and bi-pod attached to the rifle
- Purchased on February 11, 2017
- Sunrise Tactical Supply – Coral Springs

- Eight magazines recovered from the scene
- 30 and 40 round magazines



Nikolas Cruz's Weapons

- Cruz owned an additional 6 firearms:
 - Ruger .30-06 rifle
 - Century Arms 7.62 rifle (AK-style)
 - Remington 12 gauge shotgun
 - Hi-Point 9x19 mm rifle
 - Mossberg 12 gauge shotguns (2)
 - Swastikas etched on stock of one of the shotguns
- Stored at Snead residence and friend's (Hunter McCutcheon) house



Nikolas Cruz's Weapons

- James Snead had guns hidden in his house but Cruz did not know where they were. Some of them were hidden in Cruz's closet.
- The Sneads knew Cruz had multiple guns.
- Cruz's guns were kept in a safe, James had a key and Cruz may have had a key.
- The person who sold the safe said he *believed* there were two keys and that James was making Cruz give him one of the two.
- James believed the guns and ammo were kept separate from one another, possibly in different safes.
- JT knew Cruz had his own ammo separate, James did not know that.
- Cruz kept his guns and his ammo in his safe in his room.
- James Snead described Cruz as having an interest, appreciation for guns.
