

The V ambulates independently. The V is able to perform his ADLs independently as well however at times lacks the motivation to address his personal care needs in the midst of an episode. The V has capacity based on PI's observation and collateral statements. The V lives with his mother AP, brother and two dogs in the Parkland area. The V's home was clean, no clutter observed anywhere in the home. All the utilities were working order. There were no foul odors detected in the home or from the V. The V presented well, dressed appropriately. PI was not able to see any scars or cuts on the V's arms because he was wearing long sleeves. No other marks or bruising was observed on the V. The V has capacity based on PI and Deputy Feduik's observation, assessment and the statement from Counselor statement. PI reviewed

the allegations with the V.
