The individual believed to have been the shooter has been positively identified as Seung-Hui Cho via fingerprints. Initial investigation has determined that Cho committed suicide subsequent to the shooting rampage. A joint investigation continues. The following agencies are participating in this investigation: Virginia Tech Police Department, the Blacksburg Police Department, the Montgomery County Sheriff's Department, the Virginia State Police (VSP), the Immigration and Naturalization Service (INS), the Drug Enforcement Administration (DEA), the Bureau of Alcohol Tobacco and Firearms (BATF), and the Federal Bureau of Investigation (FBI). The investigation to date has not determined any connection of this shooter to either any terrorist organization/group or any secondary co-conspirator(s). Preliminary investigation indicates that CHO is likely the single shooter in this matter. In addition, investigation has not determined any connection between these shootings and recent bomb threats received by Virginia Tech.

On 04/16/2007, Virginia Tech Police Chief Wendell Flinchum requested FBI assistance in this matter. Chief Wendell will also provide a formal written request for assistance.

For information of the receiving office the FBI was notified by NBC News in New York, New York that NBC was in receipt of a Express Mail package which bore the return address [REDACTED] Officials at NBC advised that they determined via the Express Mail sticker on this package that it was mailed from Blacksburg, Virginia at 9:01 am on 04/16/2007 by a Postal Clerk using the initials "SM" or "SB". NBC officials further advised that this package was opened by NBC personnel who discovered that the package contained a copy of a seven page "manifesto" believed to have been generated by subject CHO. In addition this package was described as containing several photographs of CHO holding an assortment of what was described as long guns.

Investigation by Richmond Division has identified the Postal Clerk in Blacksburg, Virginia who processed this package. this clerk's initials were determined to be "SB". The clerk recalled observing subject CHO in his/her line in the Post Office in Blacksburg, Virginia on 04/16/2007 at approximately 9:00 am. the clerk recalled that CHO only mailed one Express Mail package.

FBI Richmond believes that the "manifesto" found in the package mailed to NBC may in fact be a copy of a seven page document recovered in CHO's dorm room at Virginia Tech on 04/17/2007 during the execution of a search warrant. It should also be noted that mailing of the package in question occurred during a period of time between the two shooting incidents which took place on the campus of Virginia Tech on 4/16/2007.

"I was in his playwriting class last fall. I was always a quiet guy myself, not really making too many friends during my years at Virginia Tech. On a couple of occasions, we'd end up sitting close to each other. I had always thought that Cho was a little "off" but since I was strange in my own right, I didn't think too much of it. People like Cho and I never seem to make friends easily and the fact that we were both loners of sorts made me pay a little more attention to him than usual.

Just before Christmas I passed by Seung Cho while he was walking around the Drill Field, a little more sad-looking than usual. I offered him a cigarette which he refused with a wave of his hand. I then tried to talk to him about one of the plays we had recently reviewed in class and he finally started talking a little. We talked about the plot and the characters when suddenly Cho asked me what others had thought about his "Richard McBeef" story.

It was then that I told Seung Cho that some of the others in the class were a little concerned with his writing. Seung seemed to get a kick out of that because he suddenly had a smile where only a grin existed before. I told him that some people were talking about him before class, talking about he was a little strange acting and with this play of his, some other students joked about him being a charter member of the trenchcoat mafia. Cho wondered what that was, so I told him about the whole Littleton, Colorado school shooting. He seemed intrigued by my words. We talked a little more about "sticking it to the man" and how good it feels to break things sometimes. I used to steal cars and smash

them into buildings, Seung mentioned he liked to hurt things. I didn't ask anymore questions.

After that day I thought differently about Seung-Hui Cho. I thought I might read about him in the paper one day, and not for any good reason.

And then it happened. All over the news. School shooting at Virginia Tech. My first thoughts when my mother called and asked me if I was okay was, "I wonder if it was Cho?!" After getting off the phone with my mom, I smiled a little knowing that Cho had gotten what he wanted. Revenge.

Cho Seung-Hui has gone and done what many of us "loners" only wish we had the courage do to. I too have often thought of taking my anger out on innocents, but unlike Seung Cho, I just don't have the courage to pull the trigger. He did.

I feel bad for the victims, but not too much. Perhaps people will start paying closer attention to us loners before we end up making ourselves popular, for all the wrong reasons!"

This EC also provided the details of Title 18, U.S.C., Section 540B which governs the FBI's investigation of serial killings. Specifically, Section 540B authorizes the FBI to investigate serial killings at the specific request of the head of the state or local law enforcement agency with existing investigative jurisdiction.

On 04/16/2007, Virginia Tech Police Chief Wendell Flinchum requested FBI assistance in the captioned serial killing investigation.

After reviewing the facts and circumstances of the case provided by Richmond Division, CID, NCAVC, and OGC have concluded that the case presented meets the requirement to justify the FBI's involvement as outlined in Title 18, U.S.C., Section 540B. **Therefore, CID concurs in the opening of the new 306 matter.**

Regarding the investigative procedures under 306 matters, it should be noted that unlike the FBI's limited authority in domestic police cooperation (62D) matters, FBI investigations of serial killers under Section 540B are fully authorized federal investigations. Therefore, Agents may employ the full range of investigative resources and techniques in pursuit of these matters, except those requiring federal judicial or prosecutive authorization. For example, Agents can conduct physical surveillance, interview witnesses, use informants, conduct crime scene investigations, and process evidence during these investigations.

Agents conducting serial killer investigations cannot obtain most types of federal process, e.g., search warrants and federal grand jury subpoenas, because the investigations do not support federal criminal charges. Notwithstanding, local and state authorities and, if necessary, Agents, can work with state prosecutors to obtain state process in support of these investigations. In addition, Title 18, USC, Section 2516(2), authorizes state prosecutors to apply for orders for the interception of wire, oral, and electronic communications in support of murder investigations as long as the requested order conforms with state wiretap laws.

FBI investigations conducted under the authority granted in Section 540B strictly support state prosecutions for violations of state laws. Therefore, Agents investigating these matters must strictly observe the criminal procedures and laws of the state(s) where the investigation is being conducted to ensure the admissibility of evidence in the courts of that state. In particular, Agents must operate within the Constitutional limitations established by the state(s), which may exert greater restrictions on Agents than those imposed under federal law.

FBI Agents investigating serial killings under Section 540B will not supplant state and local authorities in these matters; rather, they will work with them cooperatively to solve the cases.

The shooting incidents resulted in 33 confirmed fatalities and approximately 29 non fatal injuries to other victims. The first incident took place at approximately 7:15 am in the West Ambler Johnston dormitory and resulted in two fatalities. The second incident took place approximately two hours later across campus at Norris Hall, which houses the school's engineering department. This incident resulted in 31 fatalities (to include the shooter). Initial ballistics checks indicate that one of the same weapons believed to be used by the shooter was involved in both incidents. Investigation has determined that two handguns (one 9mm and one .22 caliber) were used by the shooter. The individual believed to have been the shooter has been positively identified as CHO SEUNG-HUI via fingerprints. Initial investigation has determined that CHO committed suicide subsequent to the shooting rampage. 
