Castillo was questioned regarding an article which appeared in a NYTimes.com article. The article read as follows:
In September, Mr. LOUGHNER filled out paperwork to have his record expunged on the 2007 drug paraphernalia charge. Although he did not need to bother - he completed a diversion program, so the charge was never actually on his record - Judge Jose Luis Castillo, who handled the case in Pima County Consolidated Justice Court, said after the shooting that, in retrospect, it definitely "crossed my mind" that Mr. LOUGHNER was worried that the charge would prevent him from buying a weapon.

Castillo advised that he was the assigned judge to JARED LEE LOUGHNER's case, number CR07718864. Judges are assigned by the court administration on a rotating calendar.

By way of background, on 9/09/2007 LOUGHNER was cited for possession of drug paraphernalia, a violation of Arizona State Statue 13-3415A. On Arizona Complaint, number 502957, incident number 070909359, LOUGHNER was told to appear at the Pima County Justice Court at 10/04/2007.

On 10/04/2007 LOUGHNER appeared at the referenced court as requested. [Agents note: An audio recording of the appearance was provided by LOUGHNER and can also be downloaded at www.jp.Pima.gov] During the appearance, Castillo took factual basis of the case, gave LOUGHNER the rule 17 advisory and explained the Pima County (PC) Adult Diversion Program. LOUGHNER agreed to attend the PC Adult Diversion Program. Castillo advised that he gave a program completion deadline of 2/20/2008 to LOUGHNER which was a month longer that he normally gives because LOUGHNER was younger and in Castillo's experience, younger participants take longer to complete the program. consisted of an eight hour substance abuse class. Castillo advised that he did not remember LOUGHNER until he listened to the court recording, after which he could recall the case more than LOUGHNER as an individual. Castillo advised that LOUGHNER was respectful, and asked questions. LOUGHNER shown patience as he waited longer than normal due to computer software issues at the time of his hearing. Castillo noted that he spoke softly and physically pointed out the court window to tell LOUGHNER where LOUGHNER's Adult Diversion Program classes would be held. Castillo advised he adjusts his demeanor to the individuals in the courtroom and that his speaking softly and physically pointing out the window were indicators that LOUGHNER appeared non-threatening, or non-assuming. [agents note: the courtroom clerk advised that she also did not remember LOUGHNER from the hearing, most likely because he acted fairly normal]

Castillo advised that LOUGHNER completed the PC Adult Diversion Program in two to three weeks. Castillo advised that the motion to dismiss was filed on 10/31/2010. On 11/13/2007 the case was dismissed and a conviction was not recorded. LOUGHNER filed an Application and Order to Set Aside Judgement on 9/07/2010. On 9/09/2010 Castillo denied the request because the case was dismissed on 11/13/2007 which made the request non applicable.

Castillo advised there were several noteworthy items regarding LOUGHNER's request. First, only about 5% of the individuals convicted of the this type of crime submit the Application and Order to Set Aside, of those only half complete the paperwork without a lawyer. Second, LOUGHNER completed the PC diversion class and submitted the paperwork faster than anyone he has seen. Third, the paperwork was filled out correctly, which for those not using a lawyer is rare. Forth, very few individuals accidently/incorrectly submit the application after the case was dismissed via a diversion program.

Castillo said that while the NYtimes.com writer quoted him correctly, it was a bit out of context. At the time the Application and Order to set Aside Judgement request was received by Castillo's office there was no way for Castillo to believe LOUGHNER had submitted the request in order to pass a firearm background check. There are many reasons individuals want to have a drug conviction dismissed including job searches, security clearance applications, student loans, school applications, and personal pride, to name a few. Only in hindsight does it appear

Just before 7:00 am, SA turned on the car radio at which point the radio announcer was making a comment about the congresswoman laying the hospital. SA immediately turned off the radio. Loughner made the statement, "That's confirmation to me."
