This matter came on for consideration upon plaintiffs' Complaint to Establish Paternity and Order for Child Support against the defendant, Thomas Lane, Jr., and between the defendant and the minor child, Thomas Lane, III. The Geauga County Child Support Enforcement Agency was represented by Jonathon P. Evans, Assistant Prosecuting Attorney. Thomas Lane, Jr., having been advised of his right to obtain counsel, was represented by Robert Wantz. The plaintiff, Sarah Nolan, having been advised of her right to obtain counsel, waives the same, and represented herself.

The Court finds that Thomas Lane, Jr., has submitted blood samples for purposes of HLA Blood Group testing on August 14, 1995 at 1:30 p.m. and based upon the testing results, the probability of Thomas Lane, Jr. being the father of the minor child, Thomas Lane, III, is Ninety-Nine and Seventy-Two Percent (99.72%).

The Court further finds that Thomas Lane, Jr. was ordered by

this Court on August 3, 1995 to reimburse for the costs of the HLA Blood Group testing should he be found to be the father.

The Court further finds that Thomas Lane, Jr. acknowledges that he is the natural father of the minor child, Thomas Lane, III, date of birth: 09-19-1994.

THE COURT THEREFORE ORDERS, ADJUDGES AND DECREES that Thomas Lane, Jr. is the biological father of the minor child, Thomas Lane, III, date of birth: 09-19-1994 and that a parent and child relationship is established between them.



IT IS SO ORDERED.




