

On September 30, 2010, I sent you notice of allegations that you had violated the College's Student Discipline Code and Due Process Procedures ("the Code"). On October 4, 2010, we met to discuss the allegations. Also present at the meeting were Dr. Lorraine Morales, Assistant Vice Chancellor for Student Services, Dr. Aubrey Conover, Advanced Program Manager, and your parents. At the meeting, you indicated that you desired to withdraw from your classes at the College rather than proceed at this time with a determination of whether you have violated the Code. Subject to the conditions below, this is acceptable to the College. I will defer making a decision with respect to the allegations of misconduct involving you and in the immediate future your records will reflect that you have withdrawn from all of your classes.

In the future, if you desire to return to the College, you must first contact the President of the Northwest Campus to resolve this student code of conduct matter. At that time, a formal written decision will be rendered on the allegations against you that were discussed at our meeting on October 4, 2010. In addition, the Student Behavior Assessment Committee ("the Committee") has determined that before you may return to the College, you must first obtain a mental health clearance. A mental health clearance is an opinion issued by a mental health professional indicating whether, in the opinion of the mental health professional, your presence at the College presents a danger to yourself or others. See Paragraph VI of the Code. Again, if you desire to return to the College, the President's office can direct you to the Committee for further assistance concerning the mental health clearance.

Until you obtain a mental health clearance as set out above, you should not be present on College property or attend any College event or activity without my express written permission.

Notice of Immediate Suspension

To return to the College for any reason other than with permission to meet with the campus administration will result in your being arrested for criminal trespassing.

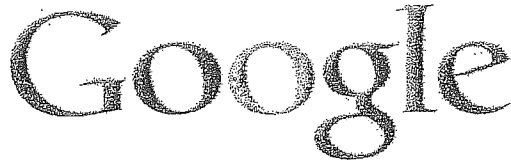
If you need to remove any of your belongings from the College, please contact College Police at 206-2700 to arrange for a police escort while on College property.
