**SUMMARY:**

On 09-27-06 at approximately 1245 hours I responded to the hostage situation at Platte Canyon High School per the request of Lt. Col. Rick Salas. Upon arrival at 1332 hours I joined the Incident Command Post as the Colorado State Patrol representative. Upon arrival my first point of concern was that Colorado 285 had been shut down at the appropriate places. Upon verifying the closures I began to work closely with Sheriff Wegner and the rest of the Incident Command post staff. I relayed information to Captain Friend in relation to various requests from the command post. I also stayed in close contact with the command post that had been established at the Colorado State Patrol headquarters at 6<sup>th</sup> & Kipling.

At the conclusion of the hostage situation, I was approached by Steve Johnson of the Colorado Bureau of Investigations and asked to coordinate the perimeter security of Platte Canyon High School. Shortly after 1600 hours I walked the perimeter of the school with Sergeant Paxton and we drew a sketch of the perimeter and coordinated our perimeter security posts. At approximately 1645 hours we established the perimeter security around the high school and middle school. The command post was moved to the old high school /administration building.

At this point I had Captain Friend, Sergeant Mason, and Sergeant Paxton work on scheduling in additional shifts of troopers for the security. I drove to headquarters and briefed the command post about the situation and our plans.

At approximately 1900 hours I responded back to Platte Canyon High School and checked on the perimeter. I noticed that the school had several doors unlocked and standing open. To make our perimeter more secure I approached Steve Johnson and asked if I could secure the open doors. He instructed me that he would appreciate my help. I located some building keys and walked the entire perimeter and personally checked every door, except the main entrance on the southeast corner, and locked them. One of our security posts on the south side was a door where the glass had been broken out of the door. We also conducted a building search on some temporary buildings on the west end of the school and secured them also.

At approximately 1145 hours Captain Kevin Eldridge arrived with the next shift of troopers. I briefed him and the replacement troopers and walked Captain Eldridge around the school. I proceeded home around 0100 hours on 09-28-06.

## SUMMARY:

On 09-27-06 at approximately 1241 hours I responded to the hostage situation at Platte Canyon High School. The command post was requesting that the State Patrol establish roadblocks on Colorado 285 and Colorado 126. Major Eicher and I arrived at the Command Post and handled the State Patrol response and assignments from there. Sgt. Dean Paxton and Sgt. Mark Mason assisted at the Command Post.

The following are some of the tasks that were handled by the State Patrol out of the Command Post:

- The initial response of CSP troopers.
- The closure of Colorado 285 north and south of the school.
- Notifying and meeting with CDOT for the long-term closure of Colorado 285.
- Traffic control at Deer Creek Elementary School
- Assist with keeping the media out of the Deer Creek Elementary school.
- Help parents find their kids at the elementary school.
- Have troopers escort the busses of evacuating students from Platte Canyon to the elementary school.
- Coordinating with CSP dispatch for food, verifying what CSP officers had responded, etc.
- Set-up the physical security and perimeter of Platte Canyon High school for the long-term.
- Kept CSP Command Post (Denver) informed.

**SUMMARY:**

On September 27, 2006, at 1214 hours, I was in Canon City, with Cpl. Boyd Manz. Pueblo Communications notified me that Trp. Martin Kenney was en-route to Platte Canyon High School, to assist Park County Sherriff's Officers with a man with a gun. I was advised that the gunman was holding hostages and that shots had been fired. I asked the communications officer to notify Captain Bruce Sheetz and advised that Cpl. Manz and I were en-route.

Cpl. Manz and I arrived in the area of the Platte Canyon High School at 1347 hours. We were told that the male suspect had seven female hostages and was held up in of the classrooms. I was advised that Fitzsimmons Middle School and the rest of the high school students were being evacuated and were being transported to Deer Creek

Elementary School. I advised the Pueblo Communications Officer that Cpl. Manz and I would respond to the elementary school and assist with the evacuation.

Cpl. Manz and I arrived at Deer Creek Elementary and were told the elementary students were going to be evacuated as well. Cpl. Manz and I assisted with the evacuation of the elementary school students. The buses from the middle school and the high school started arriving, and Cpl. Manz and I assisted with getting the students to their waiting parents.

While evacuating the elementary school, I was advised of a female parent that had fallen and broken her ankle. I notified Pueblo Communications and asked them to send an ambulance. Cpl. Manz and I located the female and carried her to an area where the ambulance could assist her. The ambulance transported the female.


Captain Sheetz arrived and assisted with the evacuation of the school buses, as they arrived from the middle and high school. During the evacuation, Captain Sheetz advised that the suspect at the high school had been shot, as well as one hostage. Cpl. Manz and I finished with the evacuation of the students, got the other students with their parents and cleared the elementary school.

Cpl. Manz and I responded back to the high school, where Cpl. Manz was released to go home. I assisted with taking the schoolteachers home including the middle school and the high school principles.

I cleared the scene at approximately 2105 hours.

On September 28, 2006, at approximately 0740 hours, I arrived back at Platte Canyon High School and assisted with releasing the vehicles that were parked in the Fitzsimmons Middle School parking lot. After releasing most of the vehicles, I assisted with the perimeter security, making sure all the entrances and doors were secure or being manned by other officers. While completing the perimeter checks, I was asked to transport a CBI agent to Colorado 285, in the area of milepost 220, to check on a weapon that was found. I transported the agent to the area. I assisted and coned off the area, so CBI could complete their investigation. I responded back to the high school and cleared the scene at approximately 2035 hours.

On September 29, 2006, at approximately 0725 hours, I arrived back at Platte Canyon High School and assisted with releasing the vehicles that were parked at the high school, and the remainder of the vehicles that were parked at the middle school. After releasing

I advised the Jefferson County Officers of the updated information and gave them the vehicle release log sheet. I advised all the Colorado State Patrol Officers that we were being relieved and for them to clear the scene. We all cleared the scene at approximately 2025 hours.

**SYNOPSIS:** On September 27, 2006, I responded to Platte Canyon High School to assist the Park County Sheriff's Department with traffic, and other issues as needed, after a gunman entered the high school and took several students hostage. State Patrol services were utilized until 2000 hours on September 29 for crime scene security and traffic control.

**SUMMARY:** On September 27, 2006 at approximately 1238 hours, I was notified by the Pueblo Regional Communication Center (PRCC) that there was a hostage situation taking place at Platte Canyon High School involving a male subject with weapons and possibly explosives in a backpack. I was en route to the location at 1242 hours, and arrived at the incident command post, which was set up near the football field across from the school, at 1405 hours. Colorado 285 was closed north and south of the school.

I met with Major Doyle Eicher and Captain Scott Friend from District 6, who had initially responded because of their proximity to the school. I was briefed on the current status of the incident, and then was directed to assist at the roadblocks north of the school on Colorado 285. I stayed at the roadblock at approximately milepost 221 until the students were loaded on the busses and were ready to be transported to Deer Creek Elementary School.

At the elementary school, Sergeant Gary Rhoads, Trooper Boyd Manz, Trooper Laurence Thomas, and I assisted school officials with unloading the students and making sure that they were released to their parents or an authorized adult.

After the students were unloaded, I worked my way back to the incident command post, and met with Major Eicher and Captain Friend. It was decided that the State Patrol would be handling the perimeter security at the high school, and assignments were made to secure the building.

Captain Friend and I attended a law enforcement briefing at the administration building and were advised of the latest developments. After the meeting, arrangements were made to man the perimeter posts with CSP personnel in 12 hour shifts, starting at 2000 hours and 0800 hours.

I left the incident command post at approximately 2115 hours after Captain Kevin Eldridge arrived to replace me and he was briefed on our duties.

I arrived back at the incident command post the next day, September 28, at approximately 0726 hours and relieved Captain Eldridge. During the day, I coordinated the road closures and assisted with getting the school staff members to their vehicles and getting them out of the parking lot. I left the area at approximately 2107 hours, after being relieved by Captain Ron Prater.

On September 29, I returned to the area at approximately 0716 hours and relieved Captain Prater. During the day, I assisted students and staff members with retrieving their vehicles. At approximately 1500 hours, CBI turned the crime scene over to the Park County Sheriff's Department, and the security around the perimeter of the high school was de-escalated. After ensuring that sufficient manpower was allocated to the security of the building, I left the area at approximately 1716 hours.

On the night of September 28, 2006, I was assigned to work at Platte Canyon High School in Park County, State of Colorado. The assignment was Crime Scene Protection for a shooting that took place on September 27, 2006.

I was assigned perimeter security at the main parking lot entrance from Colorado 285 to the "admin" building. This was my post for the entire night except for breaks provided by Sgt. William Holt, from the Canyon City troop office.

Others on this detail from the academy were Master Trooper Jon Judson, Trooper Robert Hampton, Trooper Pete Lawrence, Trooper Michael Harris. Sgt. William Holt rotated the above troopers around to different posts and gave them brakes. Nothing unusual occurred during the shift. One investigator entered the building through Trooper Harris' post on Sgt Holt's permission. Our shift was 2000, 9-28-06 to 0800, 9-29-06.

**SUMMARY:**

On September 27, 2006 at 1215 hours, I was northbound on Colorado 285, at milepost 250. I observed a highway sign showing that Colorado 285 was closed in Bailey, Colorado. I contacted Pueblo CSP via cell phone. A communications officer advised me that a school shooting had happened at Platte Canyon High School. I had the communications officer ask Captain Sheetz if he wanted me to come on duty. Captain Sheetz advised the communications officer "Yes." I drove to my residence and came on duty at approximately 1245 hours.

I was assigned to the school bus escort. I met the school buses at Colorado 285, and Park County Road 64-A. I escorted the school buses to the football practice field. I assisted the teachers and staff in getting all the high school students on the buses in an orderly fashion. I then escorted the school buses up to Deer Creek Elementary School. I assisted Captain Sheetz and Sgt. Rhoads in off loading the school buses, and crowd control. I then transported some counselors, and school staff members back to Platte Canyon High School.

I escorted the parents of the students that were in the classroom, to Platte Canyon High School from Deer Creek Elementary School. Several C.B.I. investigators at the administrative building met the parents. At approximately 1845 hours, I then was

**SUMMARY:**

On September 27, 2006 at approximately 1245, I was in the parking lot of the Golden State Patrol Office. I overheard on my Pac-Set Radio, that Park County Sheriff's Office was requesting assistance for a man with a firearm that had hostages at the Platte Canyon High School. As I heard this being aired over the radio, Sergeant Mason was leaving the Golden office. I told Trooper Keadle what was happening, and we both got in our cars to respond. We followed Sergeant Mason out of the office, and were en route to the high school.

While en route, Colorado State Patrol Dispatch established the first roadblock that was to be set up. Trooper Keadle and myself initially set up at the intersection of Jefferson County 126 and Colorado 285, to block traffic from traveling southbound on Colorado 285 in the direction of the crime scene. Sergeant Mason continued onto the high school. Shortly after setting up the roadblock, it was determined that an alternate roadblock was needed, closer to the school. Sergeant Paxton volunteered to take over the roadblock that Trooper Keadle and I were on, and Trooper Keadle and I moved on to set up a roadblock at the intersection of Colorado 285 and Mooredale Road. Trooper Keadle and I set up at Colorado 285 and Mooredale Road, and kept traffic from traveling southbound on Colorado 285 towards the high school.

At approximately 1530, I was sent to Colorado 285 and Park County Road 64 to relieve two Division of Wildlife Officers. I remained on scene at Colorado 285 and P.C.R. 64, preventing northbound traffic from entering the crime scene. At approximately 2100, I was relieved of my duties and went in an off duty status.


After meeting up with Captain Sheetz at the Canon City State Patrol Office at approximately 1251 hours, Master-Sergeant Long and I responded to the area. We arrived at the southern roadblock at County Road 64 and Colorado 285 to assist. While at that location, Long and I were advised there were more traffic problems at County Road 43 and Colorado 285 near Deer Valley Elementary School. We responded there to assist with traffic control. After the traffic cleared, we responded to the Incident Command Post.

At the Command Post, Sergeant Mason directed me to the Northeast corner of the building to watch the door there, while Long was directed to the Southwest corner. I stayed at the Northeast corner until I was relieved by Trooper Thomas.

I responded to Long's location until he was relieved by Sergeant Mason. I picked up Long and we left the scene at 1948 hours.

On 09/28/06 I provided perimeter security at the high school from approximately 0800 to 2000 hours. I manned the Northeast door for the majority of the day and was positioned at the South-central door from approximately 1800-2000 hours. I was relieved of my duties at approximately 2000 hours and I left the scene.

On 09-27-06 at approximately 1241 hours I responded to the hostage situation at Platte Canyon High School. The command post was requesting Troopers to establish a roadblock and state highway 285 and state highway 126. 6A21 and 6A15 were dispatched and I responded to assist them. I arrived at CO 126 and CO 285 at approximately 1305 hours and assisted 6A21 and 6A15 in stopping all traffic from going south on CO 285. Shortly after establishing the roadblock at CO 126 the decision was made to move the roadblock to CO 285 and Park County Rd. 64. I assisted Troopers at CO 285 and CR 64 in establishing the roadblock and relayed information to parents and media at that location.

At approximately 1438 hours I responded to the command post and assisted Command 60 and C-8 with relaying information to the Troopers at the roadblocks. Shortly after 1600 hours Command 60 and myself walked the perimeter of the school to establish security posts per CBI. By 1645 hours we established the perimeter security around the high school and middle school. The command post was moved to the old high school administration building.

I relieved Troopers for breaks until approximately 2000 hours when CBI advised me that they found the suspect vehicle and asked me to secure the vehicle. I watched the vehicle and placed paper over the license plates with evidence tape. At 2030 hours I was relieved by S22.

**SYNOPSIS:** On September 27, 2006 a shooting occurred at Platte Canyon High School (PCHS) near Bailey, CO. One victim was shot and killed. The suspect shot and killed himself. The CSP was called to assist.

**INVOLVEMENT'S:**

On 09/27/06 at approximately 1217 hours, I was eating lunch with Sergeant Rhoads, Trooper Boyd, and Corporal Rollins. At that time Sergeant Rhoads received a cell phone call stating there was a hostage/school shooting at Platte Canyon High School near Bailey in Park County, Colorado. Sergeant Rhoads was visibly upset. Rollins and I told he and Boyd to get going, we would take care of lunch. Rollins and I finished our lunch and drove to the Canon City CSP office.

At the Canon City office, we met with Captain Sheetz. He told Rollins and I that the three of us would be responding to PCHS. He left at that time. Rollins and I went into the troop office to get relay. At that time we drove to the Bailey area. We were directed to assist at the south roadblock at Park County Road 64 and Colorado 285 to help with traffic control. Colo. Division of Wildlife had that situation well under control. A short time later we were directed to assist with traffic control at the intersection of Colo. 285 and Park County 43. We were then directed to Deer Valley Elementary School to assist with traffic control there. After the traffic cleared, we responded to the Incident Command Post.

At the Command Post, Sergeant Mason directed me to the southwest corner of the high school building to watch the door there. I was later moved a few yards to the north to secure the open door to the lunchroom. Sergeant Mason later relieved me. At 1948 hours, Rollins and I left for home.

On September 27, 2006, I was patrolling on U.S. 285 near Jefferson, Park County, Colorado. At 1210 hours, I notified CSP dispatch in Pueblo that Park County dispatch was reporting a school hostage situation. Shortly thereafter, CSP dispatch advised me that there was an incident at the Platte Canyon High School in Bailey and that a CSP supervisor had been notified of my involvement. I arrived in the area of the school, near Colorado 285, milepost 218, at 1226 hours.

I parked my unmarked patrol car in the southernmost parking lot of the Fitzsimmons Middle School. I noticed that PCSO Deputy Carrigan (in-training) and PCSO Reserve Officer Wheat were there also. Carrigan and Wheat stated that they were there to secure the southern doors of the middle school. Carrigan and Wheat also stated that it was unclear what, if any, areas of the school were secure. They stated that there were at least 8 S.W.A.T. officers inside the school somewhere. The high school and the middle school are connected and make up one single building. I took up a position behind a marked

PCSO patrol car and covered the two doorways to the middle school. At an unknown time, a white female came running from the building and headed towards my position. It was determined that the female was a hostage who had just been released by the suspect. The female was taken to the Incident Command Post by a PCSO officer.

I later moved my position to better see and cover the area in question. I moved from the patrol car to a corner of a portable classroom located in that same parking lot. Two members of the Clear Creek County S.W.A.T. team arrived at the parking lot. PCSO officers Flint and Sonnenberg arrived at the parking lot.

The Clear Creek officers were monitoring a different radio channel than either the PCSO officers or me. I heard a muffled explosion. At that point, the Clear Creek officers' radios advised that shots were fired and the suspect and one hostage were down.

I reported to the football field where I checked in with Captain Friend and Sgt. Mason. Captain Friend directed me to return to my position and secure a set of southeasterly doors to the building. I returned to the parking lot and secured the entryways. I was relieved at approximately 2015 hours by a trooper from the Golden office.



I remained at that roadblock directing traffic until I was told to go up the road to the CDOT roadblock at Park County Road 64, and Colorado 285. I was at that location for a while, before I was asked to return to my original location at Park County Road 64A and Colorado 285. I remained at that location until Trooper Barrett relieved me at approximately 0030 hours. I returned to my residence and went off duty.

I came on duty September 28, 2006 at 1930 hours to serve as part of the security detail for Platte Canyon High School.
