UPON MY ARRIVAL, I HAD CONTACT WITH DANIELLE NIXON, WHO WAS THE REPORTING PARTY IN THIS COMPLAINT. ACCORDING TO DANIELLE, HER EX-BOYFRIEND OF TWO WEEKS, MYRON MAY, HAD JUST LEFT HER RESIDENCE. ACCORDING TO DANIELLE, MYRON HAS RECENTLY DEVELOPED A SEVERE MENTAL DISORDER. MYRON BELIEVES THAT THE POLICE ARE AFTER HIM AND ARE BUGGING HIS PHONE AND CAR AS WELL AS PLACING CAMERAS IN HIS HOME AND CAR.

MYRON CAME OVER THIS EVENING AND KNOCKED ON HER DOOR. WHEN SHE ANSWERED THE DOOR, HE NOTICED IT WAS MYRON AND TOLD HIM THAT SHE DID NOT WANT ANYTHING TO DO WITH HIM. MYRON BEGAN TO RAMBLE AND HANDED HER A PIECE TO A CAR AND ASKED HER TO KEEP IT BECAUSE THIS WAS A CAMERA THAT THE POLICE HAD PUT IN HIS VEHICLE.

AFTER MORE RAMBLING, MYRON THEN LEFT THE AREA.

ACCORDING TO DANIELLE, MYRON HAS BEEN DIAGNOSED WITH HAVING ADHD AND HAS BEEN USING PRESCRIPTION MEDICATION TO TRY TO OVERCOME THE DISORDER. SHE AND MYRON HAD BEEN DATING FOR APPROXIMATELY 15 MONTHS BEFORE THE RELATIONSHIP ENDED. MYRON DID STAY AT HER HOUSE OFF AND ON DURING THIS RELATIONSHIP AND HE DID HAVE PERSONAL ITEMS THERE INSIDE THE HOUSE.

I EXPLAINED TO DANIELLE THAT I COULD NOT ISSUE A CRIMINAL TRESPASS CARD AT THIS TIME UNTIL MYRON CAME AND GOT HIS PROPERTY FROM HER HOUSE SINCE THE RELATIONSHIP ENDED. DANIELLE TOLD ME THAT THIS MENTAL DISORDER THAT MYRON HAS, HAS BEEN STEADILY PROGRESSING FOR THE LAST SEVERAL WEEKS AND WITHIN THE LAST COUPLE OF DAYS IT HAS GOTTEN BAD.

DANIELLE STATED THAT MYRON HAS RECENTLY QUIT HIS JOB. I ASKED DANIELLE WHAT MYRON DID FOR A LIVING AND SHE TOLD ME THAT HE WAS AN ATTORNEY FOR THE DISTRICT ATTORNEY'S OFFICE. HE HAS BEEN STAYING UP FOUR TO FIVE DAYS STRAIGHT WITH NO SLEEP AND RECENTLY HE TOOK A TRIP FROM LAS CRUCES TO COLORADO AND BACK AGAIN IN ONE DAY WITH NO REASON.

DANIELLE IS CONCERNED FOR MYRON'S SAFETY AS WELL AS HIS WELL BEING. I EXPLAINED TO DANIELLE THAT I COULD CONDUCT A WELFARE CHECK ON MYRON TO MAKE SURE HE WAS OKAY AND TAKE THE APPROPRIATE STEPS NECESSARY IN CASE I FOUND ANYTHING ABOUT A MENTAL HEALTH ISSUE. ACCORDING TO DANIELLE, HE HAS NOT MADE SUICIDAL OR HOMICIDAL THREATS AT THIS TIME BUT HE WAS TAKEN TO THE MESILLA VALLEY HOSPITAL FOR A MENTAL HEALTH EVALUATION A COUPLE OF WEEKS AGO.

I ASKED DANIELLE IF SHE NEEDED A PROTECTION ORDER. SHE STATED SHE DID NOT THINK SO AND SHE HAD NOT THOUGHT ABOUT IT. I TOLD HER IF SHE DID NEED ONE THAT SHE COULD CONTACT THE POLICE DEPARTMENT IN ORDER FOR HER TO GET ASSISTANCE IN GETTING ONE. I ASKED DANIELLE IF THERE WAS ANY ASSAULT OR BATTERY DURING THIS CONVERSATION SHE HAD WITH MYRON. SHE STATED NO.

AFTER I COMPLETED MY ON SCENE INVESTIGATION WITH DANIELLE, I MET WITH OFFICER

MAGALLANES AND GAVE HIM THE INFORMATION I HAD. AFTER WE MET ABOUT THIS INCIDENT, WE WENT TO MYRON'S ADDRESS THAT DANIELLE PROVIDED, 251 N. ROADRUNNER PARKWAY, APARTMENT #1403. OFFICER MAGALLANES AND I DID ATTEMPT TO MAKE CONTACT WITH MYRON AND CONDUCT A WELFARE CHECK ON HIM; HOWEVER, HE WAS NOT HOME AT THE TIME.

ACCORDING TO DANIELLE, MYRON DRIVES A BLACK CHEVY SUV WITH TEXAS PLATES. ABLE TO RESEARCH THE INFORMATION AND GET A LICENSE PLATE ALONG WITH MYRON'S OUT AN INFORMATION. Ι **SENT** E-MAIL TO ALL LAS CRUCES POLICE **DEPARTMENT** COMMISSIONED OFFICERS AND PLACED THE INFORMATION ON THE BOLO BOARD FOR OFFICER'S SAFETY/WELFARE CHECK ON MYRON.

THIS CONCLUDES MY INVESTIGATION INTO THIS MATTER. THE CASE STATUS IS PENDING CONTACT WITH MYRON TO CHECK ON HIS WELLBEING.
