REFERENCE TO SUSPICIOUS CIRCUMSTANCES AT HIS ADDRESS LOCATED AT 251												
ROADRUNNER PARKWAY, SPACE 1403. HE ADVISED ME THAT OVER THE PAST TWO WEEKS HE												
WAS ALMOST CERTAIN THAT THERE WAS CAMERA SOMEWHERE LOCATED IN THE INTERIOR												
OF HIS RESIDENCE. HE BELIEVES HE WAS BEING WATCHED AND OBSERVED. HE STATED												
THAT HE CAN CONSTANTLY HEAR VOICES COMING THROUGH THE WALLS SPECIFICALLY												
TALKING ABOUT ACTIONS HE WAS DOING.												
AT THIS POINT, I EXPLAINED TO HIM WHAT EXACTLY HE WAS TALKING ABOUT TO WHICH HE
