Just came to pick up my 16 yo nephew Adam Nolan from his grandparents house, he appeared to be high and ran out the back door, wearing a gry/grn parka and blue jeans 507 hgt 107 wgt blk hair. He was very disoriented

As Deputies were leaving the juveniles were out of control again, deputies returned

**Supplement**

Deputies H. Bilicic and Filby responded to 11546 Wilson Mills Road for a juvenile complaint. Upon deputies arrival they were met by John Bruening, who stated that he and his wife, Nancy, were caring for their two nephews Adam Nolan and Thomas (TJ) Lane, who are 16 and 15 years old, respectively. John stated that earlier this evening there was a problem with TJ, he did not want to go to his volunteer work that is required of him for school. John stated that his wife's parents Carole and Jack Nolan are Adam, TJ's and Sadie's guardian. John further stated that since there was a problem with TJ earlier John was going to take Adam out of the house so there was not a further problem. John stated that he was going to take Adam to his AA meeting, which he has done before because of Adam's known heroin addiction. John stated that on Monday Adam is to enter court ordered treatment, from prior charges. John stated that Adam was acting odd and had blood shot eyes. John asked Adam if he was under the influence, Adam got angry stated that he was not going with John and left the house. Both John and Nancy were calling for Adam, they were concerned for his welfare due to the weather conditions when he did not return home. Deputies were leaving the residence to check the area for Adam, when he was observed at Winchester and Wilson Mills, deputies spoke with Adam who stated that he left the house because he got into an argument with his uncle and thought he may hit him. Adam was returned to the residence and stated that he was not going to cause a problem and agreed to stay in the residence.

As deputies were leaving dispatch advised that Nancy was back on 911 stating that her husband, Adam and TJ were physically fighting. Deputies could hear parties yelling while in the garage.

John stated that when they got back into the house he told Adam that he wanted to talk to him, Adam continued to walk into his bedroom, John grabbed Adam's coat and Adam turned around and punched John. At this point a fight continued where TJ also jumped on John attempting to put him in a 'choke hold' while Adam grabbed John's legs. Nancy came into the room attempting to break up the fight and called 911. Deputies Bilicic and Filby entered the residence and observed John bleeding from the mouth and blood on the kitchen floor. Deputies spoke with Adam who stated that when he got back into the residence John had hit him and Adam punched him back. There were no bruises or marks to Adam. TJ stated that he was helping his brother out because he assumed John was hurting Adam.

Photos were taken of John and his injuries. John stated that he would complete a statement and wished charges to be filed against Adam and TJ. Green sheets were completed for both Adam and TJ.

Carole and Jack Nolan arrived home and it was explained to them what had transpired. Carole was upset, she felt that filing charges was going to ruin Adam's life. Carole was difficult to calm down, she continuously stated that Adam could not go to court because that would screw up Adam's rehab that he is to enter on Monday. It was repeatedly explained to Carole that the courts ordered Adam's treatment and that the charges would not interfere with Adam's rehab. Carole continued to yell at Adam and TJ and then would yell at Nancy.

Carole and Jack both stated that they felt comfortable with Adam and TJ staying at the residence for the evening.

Green sheets completed for Adam Nolan and TJ Lane for assault.
